1 Purpose of Report

1.1 To advise of the allocation of Neighbourhood Learning in Deprived Communities Funds (NLDCF) from the Learning and Skills Council for 2009/10.

- 2.1 It is agreed for Oldham Council to act as Accountable Body for the 2009-2010 Neighbourhood Learning in Deprived Neighbourhoods Programme totalling £189,000.
- 2.2 Allocations to activity are noted.

3 Background

- 3.1 Oldham Partnership has secured almost £180,000 revenue funding from Neighbourhood Learning in Deprived Communities Funding (NLDCF) in 2009/2010 to help local voluntary and community sector organisations deliver and support learning opportunities for residents of disadvantaged neighbourhoods, with an emphasis on assisting those who wish to enter employment. Up to 75% of the NLDC funds can be used to align with Skills for Jobs activities to support workless people with pre-employment activity.
- 3.2 The allocation from the LSC also provides an additional £9,000 allocation that will fund the management of the programme by the Partnership Support Team.
- 3.3 An open commissioning process has been undertaken to determine and approve organisations to deliver appropriate activity against this criteria as detailed below:

- 3.4 A panel composed of representatives drawn from Oldham Council, Learning + Skills Council Greater Manchester, The Oldham College and Oldham Lifelong Learning Service met on Thursday 10th September to appraise the project proposals. The projects were individually scored against a detailed Appraisal Form supplied by the LSC and subsequently ranked on a preference-based list.
- 3.5 The make up of the panel ensured compliance with both local and sub regional strategies. This proposal allows funding to provide added value to this regional provision of employment and skills development support by targeting groups with specific needs that are under represented in Oldham. One of the key aims of the Greater Manchester Strategy is increasing access to employment opportunities in deprived areas. Whilst there are general sub regional services for support into work, the NLDCF support will target specific barriers to work in Oldham.
- 3.6 Oldham Council has acted as Accountable Body for previous NLDCF funding programmes and other funding streams. The Council has considerable experience and expertise undertaking this role and procedures are in place to ensure there is clear accountability and audit trails. The Partnership Support Team, who have extensive experience of managing external funding programmes, will provide the programme and performance management function alongside the Economy and Enterprise Board of the Oldham Partnership.
- 3.6 NLDCF is a time limited funding stream and therefore all commissioned activity will cease when the funding terminates. This is the intention of NLDCF and guidance stipulates that funding should only support one off activity.
