1 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Ames, Briggs and Stretton.

2 URGENT BUSINESS

There were no items of urgent business received.

3 **DECLARATIONS OF INTEREST**

Councillor Garry declared a personal interest in Item 5 of the Agenda, GMP Failsworth and Hollinwood Police report by virtue of her partner being employed by Greater Manchester Police.

4 PUBLIC QUESTION TIME

The following public questions were received from Mr. Andy Hunter-Rossall:

- 1. There is a muddy path between the health centre car park and the canal which is a bit of an eyesore. Who owns this section of land? Can we get some surfacing on this path? The whole triangular patch of grass here is often trampled to mud. Creating a path here may prevent this, but other suggestions for beautifying this patch would also be welcome such as planting something large enough to prevent trampling across the middle of the patch.
- 2. I've spotted a couple of times recently that the lighting along the canal is on during the day. This tends to happen on cloudy days, and I presume there is some kind that there is some kind of light sensor, but the lighting has certainly been on in the middle of the day, and when nearby streetlights have not been on. Could the council look in to whether there is a possible saving of money and energy by putting a timer on these lights as well?
- 3. As I'm sure you are aware, there's a team of volunteers who meet every 6 weeks to improve the section of the Rochdale Canal through Failsworth. We will be out again this Sunday, meeting at 10am in the Royal Oak carpark all volunteers are welcome. We would love to repaint the locks, cut back vegetation overhanging the paths and growing out of the walls, etc, and other jobs, but unfortunately most of our energy goes in to picking up litter and grappling trolleys and other large items out of the canal. Are there any measures we could take to prevent trolleys ending up in the canal in the first place? Magnetic strips to lock the Whate? Bollards or other

obstructions to make it difficult for trolleys to pass? Obviously, it would be best if we could work with Tesco on this, as I presume there is a significant financial loss for them from the number of trolleys that are ending up in the canal.



Councillor Fielding gave the following response;

- 1. Item 6 of the agenda, Failsworth and Hollinwood Budget 2017/18, provided details of monies to be allocated for a path to be created from Rochdale Canal to Failsworth Health Centre.
- 2. Mr. Hunter-Rossall did raise the issue about the lights but when he was contacted about the matter he advised this was no longer an issue. The street lighting team could be contacted and if Mr. Hunter-Rossall required further assistance Councillor Fielding would provide his details.
- 3. Tesco did have magnetic strips, however if the trolleys are lifted a few inches off the ground, the strip is rendered useless. Mr. Hunter-Rossall could approach Tesco to discuss other measures and Councillor Fielding would be happy to assist if required.

5 MINUTES OF PREVIOUS MEETING HELD ON 15TH JUNE 2017

RESOLVED – That the minutes of the Failsworth and Hollinwood District Executive held on 15th June 2017 be approved.

6 FAILSWORTH & HOLLINWOOD BUDGET REPORT

The District Executive gave consideration to a report of the District Coordinator which provided details of the budgets aligned for 2017/18 Municipal Year and spend for this period. It was reported that paragraph 3.3 of the report required an amendment. The Capital works to be undertaken, a path from Rochdale Canal to the Failsworth Health Centre, at a cost of £5865.00 would be funded equally, from both Failsworth West and Failsworth East capital budgets.

An elected member enquired about monies allocated to Lower Memorial Park in the 2016/17 budget and he was advised that the Parks department were developing a scheme.

RESOLVED - That:

- The funding allocated to the Failsworth and Hollinwood District Executive for the Municipal year 2017/18 be noted.
- The funding outlined in section 3 with an amendment to section 3.3, the sum of £2,932.50 from Failsworth West capital budget and £2932.50 from Failsworth East capital budget to fund the capital works at the Failsworth Canal be agreed.

7 PARTNER UPDATES

The Local policing team were in attendance to discuss the District Executive meeting Police report.

Members were advised that reports of Anti-Social Behaviour were on the same par as the same reporting period last year

and off road bikes were becoming an increasing problem in the area.

It was reported that the burglary dwelling crime statistics had been reclassified to include sheds and detached garages and this was the reason the figures had increased this year. Violent crime statics were also up on last year and this was because the assault and harassment figures now included malicious communications, dangerous dogs and fear of violence. Members noted the update and asked questions/made observations in relation to:



- Presentation of the District Executive Police report and its contents
- Legal highs/Nitrous Oxide issues/future health issues
- Ringing 101 and associated issues with this. It was reported that work was being undertaken on the call handling of the 101 number and concerns would be fed back
- Police Surgeries and information regarding where and when surgeries were being held.

RESOLVED - That:

- 1. The District Executive Meeting police report be noted.
- A meeting between members of the District Executive and the Local Policing Team takes place to discuss the format of the Police report and future reporting to the meeting.
- 3. Copies of the posters for Police surgeries with times and dates to be advertised in the library.

Citizens Advice Bureau

Members gave consideration of an update provided by the Citizens Advice Bureau.

It was noted that at the end of May 2017 the total number of residents given assistance was 214. Debt rescheduled total was £70,292 and additional income generated through eligible benefits was £14,269.





The previous categories of 'Burglary Dwelling' and 'Burglary Other than Dwelling' are replaced by 'Burglary – Residential', and 'Burglary – Business and Community'.


Burglary – Residential (Previously Burglary Dwelling) includes:


- All buildings or parts of buildings that are within the boundary of, or form a part of, a dwelling;
- The dwelling itself, vacant dwellings, sheds, garages, outhouses, summer houses and any other structure that meets the definition of a building;
- Other premises used for residential purposes such as houseboats, residential care homes and hostels;


Burglary - Business and Community (Previously Burglary Other) includes:

- All buildings or parts of buildings that are used solely and exclusively for business purposes or are otherwise entirely outside the classification of residential burglary such as a place of worship;
- Where an outbuilding is within the boundary of a dwelling, but not forming part of the dwelling building, such as a garage or workshop and is used solely for business purposes.

Prior to the 1st April 2017 sheds, garages, outhouses, summer house, houseboats, residential care homes and hostels etc. were redorded as Burglary Other.







Hate crimes are any crimes that are targeted because of hostility or prejudice in relation to: Disability, race or ethnicity, religion or belief, sexual orientation transgender identity

A victim does not have to be a member of the group at which the hostility is targeted. In fact, anyone could be a victim of a hate crime. This can be committe pages of a person or property.

ANTI-SOCIAL BEHAVIOUR ISSUES:

Dispersal Order Authorised:

During August a Dispersal Order was authorised following reports of groups of up to 100 youths gathering and causing disorder at various locations around Failsworth and Hollinwood. Through information gained high visabilty patrols were provided and a joint partnership approach used including The Detached Youth Team and the Travel Safe Team The Dispersal Order gave us the power to move large gatherings, and also inform them if they come back in a specified time they can be arrested.

RECENT FAILSWORTH ISSUES OF NOTE:

- ASB issues on the 3G pitch at Oasis School
- Hollinwood Tram Stop groups of up to 100 youths gathering
- Youths playing on building sites
- ASB at Wrigley Head

HOT SPOT AREAS:

- Failsworth Higher Memorial park and the retail zone
- Grounds of St Johns Church, Oldham Road.

FAILSWORTH, HOLLINWOOD & LIMESIDE PRIORITIES:

We're working hard to tackle crime and anti-social behaviour to make your area a safer place to live and work. Here are the priorities we are currently tackling in your area: Priorities are reviewed regularly and correct as of 28th September 2017.

Failsworth East:

What: Anti-social behaviour

Where: Higher Memorial Park, Lower Failsworth Park and the surrounding area and streets including Cooke Street, Church Street and Ravenoak.

When: Mainly Thursday, Friday, Saturday and Sunday evenings.

In response: High visibility patrols will continue and a joint partnership approach is being used to resolve these issues and to try to identify ASB offenders

What: Anti-social behaviour

Where: Wrigley Head, Failsworth youths hanging around the large boulders drinking and being loud and causing issues for residents.

When: Mainly evenings and weekends.

In response: Officers will carry out high visibility patrols in the area to try and identify the offenders.

What: Youths on building sites

Where: Ashton Road West, Failsworth (Building site behind Tesco)

When: Various days and times including weekends.

In response: Officers will carry out high visibility patrols in the area to try and identify those involved

Failsworth West:

What: Antisocial Behaviour

Where: Failsworth Retail Area & Quay

When: Mainly Friday & Saturday evenings 5pm onwards

In response: High visibility patrols continue and a joint partnership approach is being used to resolve these issues

and to try to identify ASB offenders.

What: Youths causing annoyance at the Metro link

Where: Between Hardman Lane Tram stop and Hollinwood tram stop.

When: Mainly Friday & Saturday evenings 5pm onwards

In response: We continue to address the issue by carrying out high visibility patrols and working with partner

agencies.

What: ASB on building sites

Where: Greaves Avenue, Failsworth

When: Various times and days including weekends

In response: Officers will carry out high visibility patrols in the area to try and identify those involved.

Hollinwood and Limeside:

What: An increase in antisocial behaviour on the 3G pitch

Where: 3G pitch - Oasis Academy Oldham - Hollins Road

When: Various days and times including weekends

In response: High visibility patrols continue and a joint partnership approach is being used to resolve these issues

and to try to identify ASB offenders

What: ASB with youths on building site and golf course.

Where: Whitebank Road and Green Lane

When: Various days and times including weekends.

In response: We have seen an increase in reports of children on the building site and also on the golf course. Officers

will carry out high visibility patrols in the area to try and identify those involved.

BRIEFING TO THE DISTRICT EXECUTIVE

Report Title: District Dementia Champion

Background:

In September 2016, the Council discussed and deferred a motion regarding improving the support given to those suffering from, and those caring for those suffering from Dementia in Oldham. The full motion wording is below

This Council notes that

- Dementia is one of the biggest health issues facing the UK
- In Oldham, over 2,500 people are estimated to be living with dementia
- This condition will affect one in three people over the age of 65, with that figure is predicted to rise by two thirds by 2030
- Dementia is an umbrella term for a set of symptoms that might be exhibited by people living with one of any number of diseases of the brain; it is not a natural part of aging
- Dementia is not just about losing your memory; it can also affect thinking, communication, inhibitions, and everyday tasks
- With the right care, support and understanding from those around them that it
 is possible for someone to live well with dementia and to continue to contribute
 to community life

Council commends the work that has been done so far in our borough specially:

- The training of well over 5,000 Dementia Friends across the borough
- Gaining recognition from the Alzheimer's Society as one of just fifty communities in England as 'Working towards a dementia friendly community'
- Establishing the Oldham Dementia Partnership and the Oldham Dementia Action Alliance
- Creating an Enhanced Memory Service to support people living with dementia and their carers

But Council also believes that as a major public-service organisation we can do so much more, particularly in:

- Delivering more dementia-friendly services with specially trained staff and from dementia-friendly buildings
- Promoting a more dementia-friendly transport network in order that people living with dementia and their carers can better access them

Council therefore calls upon the relevant Cabinet Member(s) to:

- Appoint a senior officer in each directorate as a Dementia Champion to lead on this issue within their directorate, with specific responsibility for ensuring that:
 - All new Council staff appointed to customer-facing roles, particularly those in the Call Centre, the First Contact centre and our public libraries and parks, participate in mandatory Dementia Friends training as part of their induction.
 - Existing staff in customer-facing roles participate in Dementia Friends training within twelve months.
 - Environmental checks are carried out in all of the public buildings and open spaces within their directorate's control to ensure that they are Dementia Friendly.
 - The Dementia Friendly logo is displayed prominently at these locations once they are determined to be dementia friendly.
 - Their directorate, and the Dementia Friendly public buildings and open spaces, are registered separately as individual entities with the Oldham Dementia Action Alliance, in addition to the Council being itself registered corporately.
 - A report of progress for that directorate is prepared for circulation to elected members and for publication on the Council's website during Dementia Awareness Week in May 2017.
- Ask these officers to work with the national charity Making Space and the local groups Let's Be Heard and the Springboard Oldham Dementia Carers Group to support the delivery of staff training, the carrying out of environmental checks, and the completion of the registration process.
- Carry out a review of Council employment practices to ensure that best practice is being followed in offering staff living with dementia, or caring for a family member living with dementia, appropriate ongoing support and flexible working arrangements.
- Ask our partner organisations, Oldham Community Leisure, Oldham Mio-Care, and Unity Partnership, to make similar commitments.
- Create a new Dementia Hub in an accessible, dementia-friendly Council building by providing accommodation to co-locate relevant staff from the following organisations – the Alzheimer's Society, Age UK Oldham, Making Space and the Memory Assessment Service – and meeting rooms and activity areas for people living with dementia and their carers.
- Investigate the merits and practicalities of introducing, and promoting, a
 Dementia Buddy wristband scheme with representatives from the emergency
 services and Transport for Greater Manchester. This scheme is operational
 and actively promoted within the Metropolitan Borough of Wigan.
- Create a transport sub-group of the Oldham Dementia Action Alliance to look specifically at how bus, tram and taxi transport can be made more dementiafriendly.
- Urge schools to include information about living with dementia into the local Personal Social and Health Education curriculum delivered to pupils to help develop their understanding of dementia.
- Council is also asked to appoint an elected member as a Dementia Champion to lead on this issue for Council.

The motion was referred to the Council's Overview and Scrutiny Committee, and in turn referred to that committee's Health Scrutiny sub-committee. A task group was established to look at the motion, consisting of elected members and service officers from the Council, CCG and lead providers. The group met and provided its recommendations back to Council in September 2017.

One of the recommendations from the group was that, as well as an elected member being nominated as a Dementia Champion for the Council (Cllr Vita Price has taken on this role as her role as Deputy Cabinet Member for Health & Wellbeing), it would be worthwhile if each of the six District Executives in the borough would appoint their own District Dementia Champion.

What would a District Dementia Champion do?

The idea behind each of the Districts appointing a Dementia champion, is that it would ensure that within each of the six districts, it is guaranteed that at least one of the elected members is aware of the challenges those suffering from Dementia face, and understand what support is required and available to both them and their carers in the borough.

The nominated elected member will be supported to develop their understanding of Dementia, to become a Dementia Friend or Dementia Friends Champion, be involved in the development of a new Dementia Strategy for Oldham and to act as a key point of contact for fellow councillors who may have questions regarding Dementia.

Should there be the demand, Districts are fine to nominate more than one elected member to be a District Dementia Champion.

Recommendations:

The District Executive is asked to nominate an elected member to become the Dementia Champion for their district.

Role of Dementia Champion

- Attend / help organise Dementia Friends training and associated events
 - Encourage other councillors to attend and become Dementia Friends / Champions
 - Act as advocate for the Dementia Friends scheme
 - Act as key contact for fellow district Councillors should they require advice on all anything related to Dementia.
- Represent the borough at any District / Borough / GM events regarding Dementia is necessary and appropriate
 - Including being aware of the GM wide Dementia United work streams and the impact for Oldham.
- Be the dedicated district elected member to work with residents, service officers and the Dementia Champion for the borough in the design of and implementation of Dementia related services and activities within the district.
