## 1 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Ames and Stretton.

## 2 URGENT BUSINESS

There were no items of urgent business received.

## 3 DECLARATIONS OF INTEREST

There were no declarations of interest received.

### 4 PUBLIC QUESTION TIME

The District Executive considered 2 public questions. The first question was submitted by Steve Ivell:

"My company is based in Failsworth and employs 32 people and we are constantly held up in traffic when exiting Wickentree Lane onto the A62 heading towards Oldham. The problem is caused by poor phasing of the traffic lights at the junction between the A62 and M60. The current setup allows the M60 traffic to exit onto the A62 towards Oldham but the lights stay on green for so long that the traffic snakes across the junction and blocks A62 Oldham bound traffic from moving when the lights turn green. By the time the traffic clears only a few cars are able to cross the junction before the lights return to red. This causes total gridlock at the junction but also well back into Failsworth (often well past Failsworth Pole).

I asked the Executive for help with this some time ago after I had written to SCOOT (who control the traffic lights for Greater Manchester) and no improvement was made. I enclose a copy of the response from UTC from 2014. Nothing has been done to improve the situation and now a yellow box has been added to the junction but is actually making matters worse in Failsworth What can the executive and Oldham Council do to improve the situation which is not only troublesome but dangerous due to cars ignoring the red signals out of sheer frustration."

Members were provided with details of the response from Transport for Greater Manchester. (TfGM)

The Executive discussed the issue around the junction of A62 and M60 and agreed that it would be beneficial to check with TfGM if the lights had been phased differently to try and alleviate problems at the junction but also recognised that parking/traffic enforcement would be beneficial at the junction also. RESOLVED – That Councillor Briggs would be the point of contact for the questioner and contact would be made with Oldham Council Traffic Section, Transport for Greater Manchester and Parking Enforcement.



The second question was submitted by Mr. Davis: "Some time ago I asked Councillor Bates via this District Executive a question regarding his allowances that were to be spent in the local community.

I was worried at the time as we were coming to the end of the financial year and that Councillor Bates would spend these allowances and people in the local community would miss out. I'm glad I asked this question because Councillor Bates did spend most of his allowances that year. However £1300 was spent on a fancy dress outfit and I was wondering how many times this had been used and what were the events it was used at, were they local event?"

Councillor Bates responded by explaining to Mr. Davis that the money was spent on a PCSO outfit for Greater Manchester Police to use in schools to educate children about crime/antisocial behaviour and he could not provide the information about how many times the outfit had been used. The District Co-coordinator agreed to contact the police in order to gain this information and provide this to Mr. Davis.





On the 1st of April 2017 the way we record Burglaries changed.

The previous categories of 'Burglary Dwelling' and 'Burglary Other than Dwelling' are replaced by 'Burglary – Residential', and 'Burglary – Business and Community'.

Burglary – Residential (Previously Burglary Dwelling) includes:

All buildings or parts of buildings that are within the boundary of, or form a part of, a dwelling;

• The dwelling itself, vacant dwellings, sheds, garages, outhouses, summer houses and any other structure that meets the definition of a building;


Other premises used for residential purposes such as houseboats, residential care homes and hostels;

Burglary - Business and Community (Previously Burglary Other) includes:


• All buildings or parts of buildings that are used solely and exclusively for business purposes or are otherwise entirely outside the classification of residential burglary such as a place of worship;

• Where an outbuilding is within the boundary of a dwelling, but not forming part of the dwelling building, such as a garage or workshop and is used solely for business purposes.

Prior to the 1st April 2017 sheds, garages, outhouses, summer house, houseboats, residential care homes and hostels etc. were recorded by Burglary Other.



Violent crime - Assault and Harassment figures now also include Malicious Communications, Dangerous Dogs and Fear of Violence



Hate crimes are any crimes that are targeted because of hostility or prejudice in relation to: Disability, race or ethnicity, religion or belief, sexual orientation transgender identity

.A victim does not have to be a member of the group at which the hostility is targeted. In fact, anyone could be a victim of a hate crime. This can be committed against a person or property.

## Suspicious Circumstances (Ring 101) immediately

Between 27<sup>th</sup> September 2016 and 19<sup>th</sup> November 2016 we received **80** reports from the residents of Failsworth, Hollinwood and Limeside of suspicious circumstances.

Between 27<sup>th</sup> September 2017 and 19<sup>th</sup> November 2017 we received **70** reports from the residents of Failsworth, Hollinwood and Limeside of suspicious circumstances.

#### HELP US TACKLE ANTI-SOCIAL BEHAVIOUR

Anti-social behaviour (ASB) includes a range of issues. Behaviour can be anti-social because it is capable of causing nuisance or annoyance to both individuals and the wider community.

Within the Failsworth, Hollinwood & Limeside we have a strong partnership approach to tackling ASB and the causes of it preventing it from reoccurring. This partnership approach includes police, local authorities and social landlords. These agencies have wide ranging powers to effectively tackle this problem.

#### **RECENT ISSUES OF NOTE:**

- Wheelie bins being set on fire behind the shops on Partington Street.
- Youths throwing fireworks around Failsworth , Hollinwood & Limeside including Limeside Park.
- Youths throwing stones at taxis Pole Lane/Ashton Road West.
- Fires and fireworks being thrown at Limeside Park, resulting in two young people being injured.
- Ram Raids at various convenience stores throughout Failsworth, Hollinwood and Limeside.

### HOT SPOT AREAS:

- Failsworth Higher Memorial park and the retail zone
- Rear of the shops on Partington Street
- Grounds of St Johns Church, Oldham Road.
- Metrolink on Slater/Hudson Street in Hollinwood
- Limeside Park
- Asda, Hollins Road , Hollinwood
- Oasis Academy Oldham, Hollins Road

#### SEASONAL THREATS

- **Burglary Dwellings and insecure property.** Please remember to lock up your house, garage, shed, greenhouse and outbuildings Consider putting vibration alarms on patio doors and windows entry can be gained by smashing a glass door panel or window pane.
- Vehicle Crime. Please do not leave vehicles unattended with the keys in the ignition while you defrost the car. Every year we have numerous reports of opportunistic thieves stealing vehicles left this way.

### FAILSWORTH, HOLLINWOOD & LIMESIDE PRIORITIES:

We're working hard to tackle crime and anti-social behaviour to make your area a safer place to live and work. Here are the priorities we are currently tackling in your area: Priorities are reviewed regularly and correct as of 17<sup>th</sup> November 2017.

Where: Various streets and locations on Limeside

When: Various days and times including evenings and weekends.



## SIDE WALK TALK – FIRST FOR GREATER MANCHESTER POLICE

Failsworth held a 'Sidewalk Talk' event at Tesco Failsworth. Side Walk Talk are a group of volunteers (adults) who are psychotherapists, counsellors and counselling degree students who recently formed the first Sidewalk Talk group in the UK. (It is not mandatory for Sidewalk Talk volunteers to be counsellors – anyone who has an interest in contributing to the wellbeing of others within their community may join. It just happens that this first group in the UK are all from a therapeutic background).

They **DO NOT** offer counselling to people, they are just **LISTENING**. They don't give advice or make judgements, they listen with empathy. They want to promote a sense of community, of belonging and caring. They believe that when we take the time to listen, we generate a sense of connection to others which contributes to positive mental health. When people need additional support services, Side Walk Talk signpost people to local organisations such as the Citizen Advice Bureau and Mental Health Services.

The event involved taking chairs out into the community and inviting members of the public to just sit and talk - about anything they choose. They have also found that people are just as happy to stand and talk to them. They don't impose what they are doing on others – they wait for them to come to them and then explain what they are doing. They believe that they bring a sense of calm to a busy, noisy environment.

This was the first time that the non-profit community listening project, Sidewalk Talk had worked alongside a UK Police service. The positive feedback and interaction with the members of the community was great and hopefully provided the help and direction people wanted.

A big thank you to the Sidewalk Talk volunteers, Road Safety Team and Tesco for helping us run a unique community listening event in Failsworth.



## FIREWORK SAFETY / CRIME PREVENTION ADVICE ROADSHOWS

The mobile police station has been located at various locations around Failsworth, Hollinwood and Limeside providing reassurance and crime prevention advice. We have received positive feedback from the community and the residents that called in and had a chat.


## **SEASONAL RISKS:**

- Lock all windows and doors even when you are at home.
- Close your curtains if out when your timer lights comes on.

## nter Crime Prevention



Don't let a thief ruin your Christmas follow these simple steps to protect your valuables:

- If you must leave things in the car make sure they are locked away out of sight and leave your most expensive purchases until last.
- Remember to shut and lock doors and windows when leaving your vehicle and NEVER leave keys in the ignition
- Portable car stereos and SAT NAV's are tempting items to steal so be sure to remove them when you leave your car
- Never leave valuables such as bags, mobile phones and coats clearly on display. Even a coat or plastic carrier bag left on a back seat can attract a thief
- Steering wheel locks and immobilisers are a good way of deterring thieves
- Put presents under the tree as late as possible or keep your tree out of view of the window.
- Make sure all your door and window locks are secure and don't forget to use them.
- Hall tables are a burglars dream, full of keys, money, phones and other valuables. Keep all such items well out of sight and range of doors and windows – thieves use rods and hooks through letter boxes and open windows to reach keys and bags.
- Don't let burglars window shop keep presents out of sight from outside your home, security mark valuable gifts before you wrap them and if you hide gifts in sheds or garages be sure the locks and windows on these buildings are secure.
- If you are planning to go away use timer switches for lights and ask a neighbour or friend to keep an eye on your home.
- Empty boxes left outside are an advert for the new goods inside dispose of packing carefully.
