Proposed Prohibition of Waiting – Lees Road, Oldham (Original Section)

Reason for Decision

The purpose of this report is to consider a request for the introduction of prohibitive waiting restrictions on the original section of Lees Road, Oldham which is accessed via the north side of Lees Road dual carriageway. The purpose of the waiting restrictions is to alleviate the obstructive parking practices taking place.

Recommendation

It is recommended that a Traffic Regulation Order be introduced - no waiting at any time (double yellow line) restrictions on part of the original section of Lees Road, Oldham in accordance with the schedule detailed at the end of this report.

Delegated Decision

Proposed Prohibition of Waiting – Lees Road, Oldham (Original Section)

1 Background

1.1 A request has been received for the introduction of waiting restrictions on the original section of Lees Road to alleviate obstructive parking practices.

2 Current Position

- 2.1 The original section of Lees Road is accessed via the dual carriageway section of Lees Road and is used by both businesses and residential properties within the area. There is also a large off street parking facility accessed via the old section of Lees Road in this location.
- 2.2 At this time there are some restrictive parking restrictions on the original section of Lees Road, however, they do not cover its entire length, ultimately on street parking does take place.
- 2.3 The concern raised by one of the businesses in the area is that vehicles parking in this are severely affecting visibility and therefore a number of damage only related accidents have occurred.
- 2.4 Observations have revealed parking does take place in this location not only within the carriageway but also on the footways often forcing pedestrians to walk in the carriageway. Ultimately vehicles parking in this location are creating a highway safety issue for all highway users.
- 2.5 In light of the above information, it is recommended that no waiting at any time restrictions be introduced to remove the problematic parking.

3 Options/Alternatives

- 3.1 Option 1: To approve the recommendation.
- 3.2 Option 2: Not to approve the recommendation.

4 Preferred Option

4.1 The preferred option to approve is Option 1.

5 Justification

5.1 The introduction of a Traffic Regulation Order on the original section of Lees Road is necessary to ensure that access can be maintained for pedestrians using the footway and to ensure motorist clearer visibility when entering and exiting the area.

9.1 The Council must be satisfied that it is expedient to make the Traffic Regulation Order in order to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or for preventing damage to the road or to any building on or near the road, or for facilitating the passage on the road or any other road of any class of traffic, including pedestrians, or for preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property or for preserving or improving the amenities of the area through which the road runs.

9.2 In addition to the above, under section 122 of the Road Traffic Regulation Act 1984, it shall be the duty of the Council so to exercise the functions conferred on them by the Act as to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. Regard must also be had to the desirability of securing and maintaining reasonable access to premises, the effect on the amenities of any locality affected and the importance of regulating and restricting the use of roads by heavy commercial vehicles so as to preserve or improve the amenities of the areas through which the roads run, the strategy produced under section 80 Environmental Protection Act 1990 (the national air quality strategy), the importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles and any other matters appearing to the Council to be relevant.
