#### Reason for the decision:

Since 2010, Oldham has contributed to the funding of speech and language therapy (SLT) services through Pennine Care NHS Foundation Trust.

The funding has been used to provide SLT services across early years, primary and secondary phases.

2018-19 contract value:

Early Years £ 22,884
Primary & Secondary £ 83,652
Total £ 106,536

Where a child or young person's speech, language and communication needs (SLCN) affect their ability to learn and access the curriculum, the service is provided to their education setting. Packages of care are tailored to the needs of the child and could include, as appropriate, detailed assessment and reports, input into individual education plans; demonstration of strategies for implementation in the classroom; training around SLCNs for professionals; direct therapy in the educational setting where appropriate for a specified period of time.

Therefore, permission is being sought to continue with the current funding arrangements, with a revised contract and service specification for April 19-20.

The revised contract will include additional funding for a speech and language therapist to work directly with children and young people and professionals identified through Oldham Virtual School.

The estimated cost for this post is £37k for 1 year 0.6 FTE funded through Pupil Premium Plus.

# Summary:

This report seeks exemption from contract procedure rules in order to make a direct award to Pennine Care NHS Foundation Trust, to provide an enhanced level of speech and language therapy services to children and young people across the borough.

The service will be delivered in conjunction with the main SLT contract between Pennine Care and NHS Oldham CCG

The service will be delivered within educational settings and focused on enabling children and young people to access the curriculum

During the contract period work will take place between Oldham Council and the CCG to develop a joint commissioning strategy for speech and language services for Oldham.

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s):

Option1: Direct award to Pennine Care NHS Foundation Trust (as set out above)

Option2: Seek quotes via the chest. - This Option would pose a significant risk in the following areas:

- Fragmentation of SLT services across two providers
- Silo working
- Two providers delivering SLT services to education settings
- Lack of cohesive approach and consistency of support and messages affecting quality of support to children and education settings

That permission is given to make a direct award to Pennine care Foundation Trust NHS

#### Implications:

What are the **financial** implications?

The re-award of the historic contract will be a continuation of existing arrangements and the

£107k costs can be met from within the Council's High Needs Block DSG allocation.

The revised contract includes a 0.6 FTE speech and language therapist at a cost of £37k for 1 year. This will be funded through the Pupil Premium grant.
