Summary:

A procurement exercise (YPO Mini Competition

Procedure Rules. The opportunity was advertised on the Chest e-procurement portal.

Implications:

What are the **financial** implications?

Environmental Services are seeking approval to purchase new machinery and award contracts to FR Sharrock who were tendered in accordance with Oldham Council's Contract Procedure Rules.

The cost of purchasing new machinery as detailed above will be circa £169k and will be Capital Expenditure.

This will be funded from the £71k budget available in 2019/20, a £42k insurance settlement received & £56k budget accelerated from 2020/21, all within the Capital Programme.

What are the legal implications?

The Council ran a quotation exercise, which was an open invitation and received 5 responses which were evaluated in accordance with the Council's Contract Procedure Rules as set out above.

The Council's Contract Procedure Rules have been complied with. (Alan Evans)

What are the *procurement* implications?

A Procurement process was undertaken in accordance with the Council's Contract Procedure Rules and the Public Contract Regulations 2015. The route to market was to utilise the YPO Framework. YPO have already completed an OJEU tendering exercise to establish a procurement framework covering several lots. On inspection of the framework documentation our requirements were covered by Lot 1: Purchase of Grounds Maintenance Equipment. All suppliers were then invited to take part in the further competition exercise.

It was advertised on The Chest Portal for 14 days. 5 tenders were received on time from Balmers, F R Sharrock, Gibson, Richard Carney and Turner. 1 supplier (ATE (UK) Ltd) opted out with the balance failing to submit any interest in the event.

The submitted bids were then evaluated against the set criteria highlighted within the Mini Competition tender document.
