**Reason for the decision:** St. Anne's C

St. Anne's CofE aided primary school's 'school street pilot' commenced on 5 June 2023 after an extensive consultation with the school SLT, residents, parents and councillors. The school street was introduced using an Experimental Traffic

Order.

The pilot included a closure of Ormerod Avenue and the introduction of one-way streets to support

the closures.

Feedback on the pilot has been positive; parents report that the junction of Ormerod Avenue and St Annes is calmer and feels safer. It is also reported that the closure of Ormerod Avenue helps to provide a secure environment for pupils and

parents.

Progressing permanent Traffic Orders to support the installation of gated control and providing footway buildout will ensure that the benefits of the School Street are improved and will remain as

permanent features

St Annes CofE Primary School parents and residents experience the following issues

associated with school pick up and drop off times:

 Long standing issues at school pick up and drop off times on Ormerod Avenue and surrounding area.

- Surrounding streets are high density terraced streets with little or no off-street parking.
- Vehicles park on both sides St Anne's Avenue, effectively making it a single lane.
- The School Street pilot has proven that the measures introduced are of benefit to the areas.

The proposed school street will restrict access on Ormerod Street.

The proposals also include making permanent the St Anne's Avenue one way, Westbound, from its junction with Oldham Road to its junction with Ormerod Avenue. Mellalieu Street one way, Southbound, from its junction with St Anne's Avenue.

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s):

The alternative is not to progress these measures and continue to use the experimental powers until they expire and continue to monitor the scheme.

Consultation: including any conflict of interest declared by relevant Cabinet Member consulted.

Highways Transport Policy officers have consulted with schools, Councillors and residents in the area. A public information event was held for residents to attend and provide feedback of the pilot.

The Ward Members have been consulted and Councillor S Bashforth said 'thanks for this and in general it is a good scheme.

Unfortunately, there are still a significant number of people who are ignoring the restrictions which is frustrating residents and generating complaints. Just last week I forwarded photos to our parking enforcement dept. showing lots of people dropping off children and parking on footpaths etc. I'm told by residents that this is a daily issue.

The scheme is good, but stricter and more regular enforcement/education is needed before people accept why this scheme is in place and respect the restrictions.

I do accept resources are limited but without a frequent presence by officers, the scheme will not be as successful as it should be.

This is not meant to be a negative comment but the message that this scheme is for the safety of all children attending the school as well as to protect residents must be firmly passed on to those who ignore it.'

#### Recommendation(s):

Permanent Traffic Regulations Order will prohibit motor vehicles from entering the School Street zone/s of each school at drop off and pick up between the times listed in Appendix A on weekdays during term time. A gated barrier will support school staff or volunteers to manage the closure.

The additional footway buildouts will further deter inconsiderate parking at the junction of Ormerod Avenue and St Annes, providing a safer environment for pedestrians.

#### Implications:

What are the **financial** implications?

The cost to progress the permanent Traffic Order at St Marys CofE school to support the installation of gated control and providing footway buildout will be circa £25k and will be capital expenditure.

This will be funded from the Schools Streets scheme with the 2024.25 Transport Capital Programme, which will be financed by Active Travel Fund grant.

What are the legal implications?

The Council must be satisfied that it is expedient to make the Traffic Regulation Order in order to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or for preventing damage to the road or to any building on or near the road, or for facilitating the passage on the road or any other road of any class of traffic, including pedestrians, or for preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property or for preserving or improving the amenities of the area through which the road runs.

In addition to the above, under section 122 of the Road Traffic Regulation Act 1984, it shall be the duty of the Council so to exercise the functions conferred on them by the Act as to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off Regard must also be had to the the highway. desirability of securing and maintaining reasonable access to premises, the effect on the amenities of any locality affected and the importance of regulating and restricting the use of roads by heavy commercial vehicles so as to preserve or improve the amenities of the areas through which the roads run, the strategy produced under section 80 Environmental Protection Act 1990 (the national air quality strategy), the importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles and any other matters appearing to the Council to be relevant. There could be reputation risks around the scheme in terms of residents reactions to the proposals these have been mitigated by the trial which has been in place since June 2023.
