1           **APOLOGIES FOR ABSENCE**

5           **MINUTES OF PREVIOUS MEETINGS**

6           **PETITIONS**

**RESOLVED** that the petition regarding Speeding Vehicles on  
Church Road, Uppermill, be referred to the Executive Director,  
Neighbourhoods, to investigate the request and produce a  
report for the District Executive, ensuring measurements of  
traffic speed are included.

7           **BUDGET REPORT**

The District Executive considered a report advising of the  
available budget for 2013/14, commitments made, and potential  
budget allocations for consideration.

**RESOLVED** that:

1. The budget available for 2013/14 be noted.
2. The budget commitments made be noted.
3. Approval for allocation of £10,000 towards the installation of an ANPR camera system on major routes in Saddleworth be delegated to the Chair, subject to receiving detailed costings of the system, and consulting all District Executive members.
4. The allocation of £20,000 towards a drainage solution at Mills Recreation Group, Lees, be approved.
5. The allocation of funds towards the resurfacing of Old Mill Lane, Springhead, be deferred to the next meeting, to allow time to discover if the programmed patch repair scheme would be undertaken using micro-asphalt.
6. The allocation of £2,000 for the implementation of a signage improvement scheme in Uppermill (option 2) be approved.
7. The allocation of £1,200 for the implementation of amendments to parking restrictions in Uppermill be approved.
8. The allocation of £3,000 towards the cost of access improvements at Uppermill Methodist Church be approved.
