## **Purpose of Report**

To seek approval for the awarding of a contract for Bikeability Cycle Training for Oldham Council.

#### **Executive Summary**

Oldham Council seeks to appoint a specialist contractor to provide Bikeability Cycle Training jointly with Unity Partnership.

The successful contractor will demonstrate:-

- a highly developed understanding of all aspects concerning cycling proficiency and associated disciplines;
- a track record of delivering high quality professional services in the public realm; and
- a socially engaged approach with a real commitment to the community and its environment.

The project will commence in September 2011 with an intensive period of consultation and engagement.

# 1 Purpose of Report

1.1 To seek approval for the awarding of a contract for Bikeability Cycle Training for Oldham Council.

#### 2 **Executive Summary**

- 2.1 Oldham Council seeks to appoint a specialist contractor to provide Bikeability Cycle Training jointly with Unity Partnership.
- 2.2 The tender was advertised on the Due North e-procurement portal "The Chest".
- 2.3 The tenderers were asked to demonstrate:-
  - a highly developed understanding of all aspects concerning cycling proficiency and associated disciplines;
  - a track record of delivering similar high quality services in the public realm; and
  - a socially engaged approach with a real commitment to the community and its environment.
- 2.4 The project will commence in September 2011 with an intensive period of consultation and engagement.

#### 3 Recommendations

3.1 It is recommended that S2S Recruit Develop Ltd are awarded the contract.

#### 4 Background

- 4.1 Oldham Council has submitted a bid to the Department for Transport to continue to deliver National Standard Cycle Training to children during 2011/12. It is our intention to use half of this funding to train the target number of 1,212 children in the Borough of Oldham to Bikeability Level 2 National Cycle Training Standard. It is possible that the remainder of the funding will be used at a later date to deliver further training.
- 4.2 In awarding the grants the Department of Transport has emphasised that grant recipients must ensure value for money.

#### 5 The Tender Process

- 5.1 The opportunity was advertised via 'The Chest', and a total of 16 companies expressed their interest in this project.
- In accordance with the Council's Contract Procedure Rules, the evaluation of the tender submissions has sought to identify the submission offering best value, based upon a combination of economy, efficiency and effectiveness. The weightings applied to the tender submissions have been:
  - Technical ability 40%
  - Price 60%
- 5.3 The tender evaluation was undertaken by Jenny Lukoczki (Corporate Procurement Lead), Julie Williams (Senior Road Safety Officer), and Paul Bruffell (Cycling and Walking Officer).
- 5.4 Of the 16 companies that expressed an interest, 6 submitted an ITT response.

The six companies (in alphabetical order) are listed below;

- BikeRight!
- Cycle Experience
- Cycling Solutions Community Interest Company
- Peak Pursuits Ltd
- S2S Recruit and Develop
- The National Cycling Academy
- 5.5 The tenders submitted were evaluated in accordance with the aforementioned criteria. The scores of the evaluation process in ascending order were;-
  - 86.59
  - 87.27
  - 87.95
  - 91.00
  - 93.03
  - 99.32
- 5.6 The estimated value of the contract is £41,208.00.

#### 6 Options/Alternatives

- 6.1 To not award a contract. This would result in the loss of funding.
- 6.2 To award the contract to the most economically advantageous bidder.

#### 7 Preferred Option

7.1 To award the contract to the most economically advantageous bidder.

#### 8 **Consultation**

8.1 Regular consultation took place throughout the tender process with Oldham Council and the Unity Partnership, involving the relevant departments at all stages of the process.

#### 9 Finance Implications

- 9.1 The Council has secured funding of £96,960 for the provision of cycle training to school children from the Department of Transport (Dft) subject to grant claims and the required back up documentation being submitted.
- 9.2 The above funding will provide training for a minimum of 2,424 children at the maximum claimable cost per child of £40.
- 9.3 It is the intention for the Council to provide training to half the number of children through this contract. The other half will be procured separately by Unity through a joint initiative with Rochdale
- 9.4 The above grant funds the project 100%.
