Subject: Proposal to allocate Section 106 resources from DB 301 -

Land at Byron Street, Hollinwood. (PA/57174) for installation of new play equipment and enhanced landscaping improvements to the playscape at Incline

Road.

**Reason for the decision:** The report is to seek approval for the allocation of resources

secured through a Section 106 planning obligation to fund the installation of new play equipment and enhanced landscaping

improvements to the playscape at Incline Road.

**Summary:** This report seeks to allocate the remaining £14,790.35

funding from DB 301 - Land at Byron Street, Hollinwood. (PA/57174) to Environmental Services towards this scheme to install new play equipment and to provide landscaping

improvements to the playscape at Incline Road.

Planning permission for the development at Byron Street, Hollinwood. (PA/57174) was granted subject to the developer first entering into a Section 106 planning obligation. This obligation was signed on 20/10/2010, whereby the developer agreed to pay £36,000 as a capital contribution for the cost of improving public open spaces and the highway and £43,200 as a revenue contribution representing 12 yrs maintenance,



including maintenance of any land to be transferred to the Council.

The agreement specifies that the commuted sum shall be used for the enhancement and maintenance of the Cardigan Road play area, the PC Armitage memorial garden, the Incline Road play area and for any other environmental improvements and enhancements to POS within the Hollinwood area.

With interest accrued since receipt of the funding, the total amount available from this agreement has totalled £81,408.47. Schemes have already been developed for Cardigan Road and the PC Memorial, leaving a total of £14,790.35 \$106 funding remaining for Incline Road.

The scheme has been designed by Environmental Services. It involves the installation of a multi-swing unit, surfacing enhancements/extension in order to provide good access to the equipment and the re-orientation of existing furniture, as well as planting and soft landscaping to further enhance the playspace.

The works will be delivered and managed by Environmental Services with a sub-contractor carrying out the installation of the play equipment and safety surfacing. In accordance with the Council's Contract Procedure Rules, written quotes were invited from 4 suitable contractors. Three companies submitted and the lowest quote will be accepted.

Maintenance of the site will be covered by the existing maintenance budget in place for the playspace.

What are the alternative option(s) to be considered? Please give

Option 1 - To allocate £14,790.35 funding from DB301 towards the scheme and comply with the obligation within the S106 agreement. This is the preferred option.

the reason(s) for recommendation(s):

Option 2 - Do nothing - do not allocate the Section 106 funding from DB301, and do not go ahead with the scheme. This will mean that the requirement of the Section 106 agreement to use the funding for the improvement of Incline Road play space will not be met, and that the funding may be returned to the developer.

Consultation was carried out as part of the planning process prior to the approval of the development. This process resulted in the requirement for the developer to enter into a S106 agreement and to pay a commuted sum for improvements to nearby public open space, and this specifically included the play space at Incline Road

## Recommendation(s):

To approve the allocation of £14,790.35 section 106 resources from DB 301 - Land at Byron Street, Hollinwood. (PA/57174) to Environmental Services for the purposes of the installation of new play equipment and enhanced landscaping improvements to the play scape at Incline Road.

## Implications:

The balance held in respect of S106 funding line (DB301 - Byrom Street) is currently £50,906.11. This report details a spending proposal of £14,790.35 for work on a Play Area. The balance remaining after the works have been performed will be £36,115.76 and this residual sum is fully committed against other planned activities. (Nigel Howard)
