Please give a brief description of the facilities you are requesting are improved/developed;

We wish to redesign two existing school rooms.

- 1- Infant library conversion to establish a new sensory and teaching room aimed specifically in being a working space for a small group of pupils/ specific individuals on EHC plans. Specialist provision can then be facilitated by our current trained staff to work specifically with these pupils at an appropriate level. This room would include such elements also seen in EYFS continued provision to allow a sensory approach.
- 2- Convert an old office space into a cosy library where pupils can withdraw to read, research, etc. This old office space is often used for intervention but is not fit-for-purpose so we aim to convert this into a library and intervention room.
- 3- To convert an old staff toilet into a disabled toilet (adjacent to the rooms above) to allow our pupils with disabilities to access this much easier, especially if they are developing their skills in the room adjacent.

How has the estimated cost been calculated?	£14,475.81 (for both rooms complete) +£4000 approx However, this does not include the conversion of a toilet into a children's disabled toilet as the quote has not yet been process. However, we expect this to be around £4000. Architect and Construction consultation (P&L Construction)

5. Evidence

Please provide evidence of need/level of demand in relation to the requested project;

At time of writing, Holy Cross provides for 10 pupils with a current EHC Plan with a schedule to submit applications for at least another 6 pupils, which we feel confident should be approved. 1.7% of our population are pupils on an EHC Plan which is well above the LA average of 1% and the primary average of 0.7%. The proportion of pupils receiving SEN support in school is 17.2%, again, much higher than the Oldham average of 11.8%. We serve children with a range of needs and disabilities, such as autism and visual impairments.

Please give details of the aims of the project, how it will improve outcomes for children young people and families;

School aims to establish a working and sensory space that will allow the above pupils to receive more focused and specialised provision suitable for their own needs. On regular and timetabled occasions, specific pupils will be able to receive more tailored provision within this space with a member of school staff designated that best fits their current needs. Provision such as water and sand and more specific sensory provision will be available to ensure all children can progress at the most relevant levels.

This space would demand that a smaller room adjacent would be converted into a library. Although the principles of this room would be the same, this of course would not be for exclusive use of children with SEND.

The toilet in this area of school is an old staff toilet and we aim to convert this into a disabled toilet for pupils to be able to use.
