DECISION: Auto and Contractual Enrolment (Pensions)

An agreement has been made by the Chair of the Overview and Scrutiny Board to authorise the decision to approve the recommendations of the Unity Partnership Shareholder Committee, with respect to the re-instatement of individuals who may not have previously been auto enrolled into the Local Government Pension Scheme (LGPS) and Teachers’ Pension Scheme (TPS).

The decision is to exempt the report from call-in. The Chair of the Overview and Scrutiny Board has agreed that the decision cannot be reasonably deferred because of the need to comply with the statutory timeline for the restaging of the Pensions Auto-Enrolment process.

The reason for urgency is that matter was not published 28 days in advance of the decision in accordance with Part 2 of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) 2012.
