Reason for the decision:	The purpose of this report is to provide an update regarding the implementation project, for the Adults Care at Home tender – category 1. This report articulates some of the issues and barriers that the team have encountered and steps put in place to manage the project going forward, for the board to consider and agree.	
Summary:	The closed version of this report articulated some of the issues that have been encountered during the early stages of the implementation, and how they have been resolved. An earlier version of this report was taken to the Adult Social Care DMT on 2 October 2019, where it was recommended for an updated version of this paper to be delivered at the Commissioning	

Partnership Board.

The closed version of the report recommends

option 2 as this supports the implementation of the cluster model, enables the transfer of packages to lead cluster providers where appropriate and reduce the impact on service users wishing to remain with their current provider, who are not on the council's preferred provider list whilst ensuring compliance with the care act, promoting service user choice and market stability.

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s):

The closed version of the report presented three options, option 1 is to continue with the current model, option 2 is to continue with the current implementation model whilst recognising that there may be circumstances where lead cluster providers may be required to deliver outside of their allocated cluster. Option 3 is disband the implementation team and cease the transition of existing packages to lead cluster providers.
