### **Reason for Decision**

Cabinet approval has already been obtained for the Northern Roots project / masterplan (2019) and acceptance of external funding allocations: namely Town Deal Fund (Cabinet 14 November 2022) and Levelling Up Round 2 (20 March 2023) grant awards, where allocations have been ringfenced for a new visitor centre and forestry skills centre.

With planning approvals in place for the proposals, this report seeks approval to draw down the funds and award a construction contract with Wilmott Dixon Construction, WDC so that the works can start on site. A fully compliant procurement process undertaken to award WDC a preconstruction services agreement (PCSA, 18 September 2023) and through this work WDC have confirmed a lump sum for the works, (which has been reviewed and verified by the Council's cost estimator) and this is within the external budget allocation. The legal, commercial, and technical details of the contract award are set out in Part B of this report.

Cabinet members are also asked to note that the delivery of the works set out in this report will act as an enabler and facilitator to further works at the site, to delivered by the Northern Roots Charity and funded from other external funding sources awarded directly to the charity.

Finally, in order to facilitate the requirements of the grant awards, Cabinet members are requested to approve delegations for: i) progressing a review of the governance arrangements for the Northern Roots Charity and project works on the site (owned by the Council); and, ii) by association, a leasing/licensing strategy to permit the delivery of the works on site.

#### Recommendations

Cabinet members are asked to:

- Note the progress to date within the report and the various objectives to be achieved by the progression of the Northern Roots project (Section 2 of this report).
- Approve the draw down of the allocated external grant awards to progress with the visitor centre, skills centre and associated works at the site.
- Approve awarding a Stage 2 design and build contract to Willmott Dixon Construction
  Limited to undertake the contract works as set out in this report. Noting robust monitoring
  of the works to ensure delivery on time, within budget and to the required standards to
  meet the funding criteria / objectives.
- Delegate authority to the Deputy Chief Executive (Place) in consultation with Portfolio holders, the Borough Solicitor and Monitoring Officer to approve the procurement and appointment of sub-contractors and service providers to supply any works, supplies or services needed to deliver the project.
- Delegate authority to the Deputy Chief Executive (Place) in consultation with Portfolio holders, the Borough Solicitor and Monitoring Officer to progress leasing/licensing arrangements to facilitate delivery of the capital build and delivery of the masterplan.
- Delegate authority to the Deputy Chief Executive (Place) in consultation with Borough Solicitor to reset the governance arrangements with the Northern Roots Charity to ensure effective working relationships, effective management of the site, and monitoring of the required objectives.

#### **Northern Roots**

## 1 Background

1.1 Cabinet approved a masterplan and charity company for the future management and delivery of the Northern Roots Project in 2019, which set out the ambition for Northern Roots as a pioneering site to harness the potential of 160 acres of urban green space, next to some of Oldham's most deprived communities. Key aspects of the original vision/masterplan included:

- Establishment of visitor infrastructure including a dedicated visitor centre
- Dedicated educational learning space.
- Associated supporting infrastructure including car parking
- Growing space including edible growing zones
- Sport and recreation
- Woodland discovery and adventure
- 1.2 The ambition for the Northern Roots site has immense potential and focuses on:
  - **People**: by producing healthy food, supporting physical activity, promoting connection with nature and community, and enhancing health and wellbeing
  - **Planet**: by managing and improving the landscape to build biodiversity, capture carbon, enhance water quality and increase ecosystem service value
  - **Place**: by generating training, education, jobs and business opportunities, attracting new visitors and investors to Oldham, and enhancing civic pride
- 1.3 The masterplan has been considered by Planning Committee and approvals are now in place for:
  - FUL/348898/22 (13<sup>th</sup> April 2022) Hybrid application seeking full/part outline consent comprising (a) Full application for the erection of visitor centre, events building with meeting pods, learning centre, forestry depot, ground mounted solar PV and associated works, relocation of football pitch provision, necessary infrastructure, hard and soft landscaping, site wide vehicular, cycle parking and pedestrian improvements, including car park on Nether Hey Street. (b) Outline application (all matters reserved except for access) for a community growing allotment and swimming pond Land at Snipe Clough Oldham
  - FUL352515/24 (12<sup>th</sup> March 2024) Full application for the erection of a visitor centre, events building, forestry depot, necessary infrastructure, hard and soft landscaping, vehicular and cycle parking and pedestrian movements.
  - RES/352568/24 (21<sup>st</sup> March 2024) Application for approval of all Reserved Matters in respect of Phase A (Upper Market Garden) relating to approved application FUL/348898/22 Land at Snipe Clough.
- 1.4 Willmott Dixon Construction Limited (WDC), were appointed 18<sup>th</sup> September 2023 as the winning bidder for the project, under a pre-construction services agreement (PCSA) to progress Phase 1 capital works for the Northern Roots project and progress detailed design for the capital build underpinning planning application FUL/35251/24. In addition to the scheme design, there has also been a requirement to undertake a package of enabling works as part of the PCSA to complete surveys and mine shaft investigations which were completed in July 2024.

- 1.5 Full details on the Northern Roots masterplan and capital phasing, benefits and the charity's sustainable business model can be found in Appendix 2 of Part B of this report.
- 1.6 Northern Roots progress and deliverables on site (to date) include:
  - Developed the Phase 1 farm supporting 2 harvests.
  - Landscape management including the creation of 6 ponds, the improvement of 10 acres of grassland and 20 acres of woodland, and 2,000 trees planted.
  - Established a community garden and wildflower meadow.
- 1.7 This has enabled to following outcomes to be achieved for Oldham's local communities, and the project / site has gained regional and national attention and accreditation by association:
  - Created 80 volunteering opportunities.
  - Supported 6 small businesses to setup on site.
  - Supported the local Oldham supply chain through the commissioning of businesses to supply goods and deliver services.
  - Delivered a diverse cultural events programme.
  - Providing educational activities for over 600 children and young people.
  - Delivered activities on site that have engaged an estimated 6,000 local residents over the last 2 years.
  - Provided services to 120 participants in the Natural Health Service.
- 1.8 The next phases of the project and delivery of the masterplan for site comprises:
  - \* a new Visitor Centre
  - \* a Forestry Skills Centre
  - \* external works including car parking facilities and access/road infrastructure
  - Playground
  - Phase 2 Farm
  - Solar Array
  - New sports pitches
  - Site wide access
  - Wild play facilities
  - Longhouse
  - Swimming Pond
- 1.9 Items marked \* are proposed to be funded and delivered by approvals from this report, and the draw down on the allocated external grant funds. The other items, listed above, are to be funded by external sources available to the Charity, and these items will be delivered by the Charity. It is envisaged that the parallel delivery of these items will provide a comprehensive offer for the local community and a true visitor experience for local residents and visitors from outside the borough.
- 1.10 The items marked \* are being referenced as Phase 1 in the remainder of this report. Northern Roots charity is raising capital funds directly for future phases of the Northern Roots Masterplan.

### 2 Phase 1: Northern Roots Project / Site Development

2.1 Phase 1 works includes the design and delivery of a Visitor Centre, Forestry Skills Centre and associated car parking, road infrastructure and walking / cycling routes to access the facilities. Specific details have been reviewed, assessed and approved through the public

- consultations undertaken by the Northern Roots Charity and the Council, and through the formally approved planning applications.
- 2.2 The following images provide a visual overview of Phase 1 proposals and site locations for the new facilities; these were provided in more detail through the planning applications (referenced earlier in this report), and the detail is still available to view through the planning portal.

- 2.3 Phase 1 has full planning consent and comprises
  - a Visitor Centre welcome area for visitors to the site, reception facility, public toilets and changing space, kitchen / cafe, community prayer room, office space for site management, two multi-purpose learning / workshop spaces and solar panels / heat pumps for sustainable energy.
  - a Forestry Skills Centre training suite for vocational courses with technical workshop spaces, storage space for equipment needed on site, small office, kitchen and welfare facilities (toilet, showers and drying room for staff and volunteers)
  - a new car park for visitors, dedicated accessible mobility parking, and electric vehicle charging stations, together with new access paths from the car park to the new facilities.
  - a small outdoor amphitheatre adjacent to the Visitor Centre to host performances, talks and school groups.
- 2.4 Enabling works which have formed part of the Preconstruction Services Agreement (PCSA) and included site surveys, intrusive site investigations including probing work to understand the presence of historic mine workings. These were necessary to be able to complete the Stage 4 design information and tender the work.
- 2.5 During the Stage 2 and Stage 3 design there have been several exercises to look at value engineering. Following completion of the PCSA, Willmott Dixon Construction have tendered the work following completion of the Stage 4 Design. A lump sum price submission which includes the PCSA has now been received from WDC and the technical, financial and legal aspects are set out in Part B of this report.
- 2.6 In parallel with Phase 1 capital delivery, the Northern Roots Charity are planning to deliver complementary recreational and visitor infrastructure and attractions, aligned to its commercial business model and these will be funded from external sources. More information is set out in Part B of this report.

## 3 Northern Roots Charity / Governance Position

- 3.1 The Council set up the Northern Roots Charity in 2022 to facilitate access to external revenue funding sources. This has been very successful, as the Northern Roots charity continues to be self-funded having attracted external funding from prestigious national and regional funders.
- 3.2 Since 2023 the Charity has invested in 50+ local businesses/freelancers, in addition to local staff. In 2024, the Charity reported to the Shareholder Committee that 31 jobs had been created at the site, with 19 posts being filled by residents of Oldham.
- 3.3 The Charity is established on Social Media with 7,000 followers and a 35,000 monthly reach. A new brand and website has been launched. Approx 6,000 local residents have been engaged in activities on site and in surrounding communities in the last 2 years.
- 3.4 In ensuring support for the delivery of the Northern Roots masterplan, resident outcomes and KPIs to 2030 include:

- 3.5 As the accountable body for the external grant awards, the Council is responsible for ensuring the delivery of the required outcomes and objectives for the benefit of Oldham's local communities, therefore this report seeks approval to review and reset the relationship with the Northern Roots Charity. This will enable new monitoring and partnership working to flourish and provide the Council will access to the relevant information to ensure compliance with the funding criteria.
- 3.6 The "reset" of the working relationship, governance and partnership between the Council and the Northern Roots Charity will maintain compliance with the Charity Commission and Companies House, and provide a new opportunity for Oldham's communities to benefit from the strengthened partnership between the Council as landlord and accountable body, and the Charity as the Council's delivery partner for managing and maintaining the site, and delivering activities on site.

#### 4 Consultation

- 4.1 Northern Roots Charity have been consulted through the various workshops and meetings to help confirm requirements, specifications, business plans and holistic opportunities to maximise the funding awards and deliverables.
- 4.2 Members of the public and wider elected members have been consulted through the various planning application processes all of which have approval.
- 4.3 Portfolio holders and Ward Councillors have been consulted as this is a Key Decision.

#### 9. Risks

9.1 There is a clearly defined risk register in place for this project, which was recently reviewed and will be consistently monitored through the established project delivery governance structure.

9.2 The recommendation to appoint the contractor will provide the Council with an opportunity to develop this area of land and construct a visitor centre and associated infrastructure. As with all construction projects of this nature, there is financial risk associated with the scheme. It should however be noted that extensive assessments including ground investigation have been undertaken through the PCSA to mitigate risk where possible and this is further mitigated through the identified project contingency budget, that the previous funding required will be outside of the Council's risk appetite and this will be reviewed by a cost consultant prior to this decision being made.

## 11. Property Implications

- 11.3 The Deputy Chief Executive (Place) in conjunction with the Borough Solicitor and Monitoring Officer will progress this land use strategy and associated lease and licensing agreements under the agreed delegations sought from this Cabinet report. Details are set out in Part B of this report.

- 14 Community cohesion, including crime and disorder implications in accordance with Section 17 of the Crime and Disorder Act 1998
- 14.1 The Northern Roots project is focused on enhancing the site to make it attractive for recreational use so that a positive impact on the poor health, deprivation and employment statistics can occur. Northern Roots will work with local health and care providers to connect people in these communities with the well documented physical and mental health benefits of spending time outdoors, working with Oldham's social prescribing network to support access to increased physical activity, healthy food and activities such as gardening and farming. In addition, Northern Roots will work with schools, colleges and universities to deliver courses, qualifications, apprenticeships and jobs, providing economic opportunities in communities where this is much needed.


