While HMOs can provide an important source of affordable accommodation, their proliferation in certain areas has led to issues including overcrowding, pressure on local services, and a decline in housing quality. In the past 5 years the number of licensed HMOs in Oldham has almost doubled.

This Council also notes that

- on 1 November 2023, it resolved to direct officers to "collect and collate evidence on the number of HMOs in each ward across the Borough, identifying clusters and report back to the relevant cabinet member if any case can be made for an Article 4 direction".
- This Council further notes that current national planning regulations allow certain HMOs (Class C4, up to six residents) to be established without the need for planning permission. This limits the ability of local authorities to manage their spread and ensure they are appropriately located and regulated.
- no figures are currently available on the number of HMOs in the borough – only for the number of licenced HMOs (which meet one definition) or for HMOs which have received planning permission (which meet a separate definition).

The 1995 and 2011 Pension Acts saw the State Pension age for women rise from 60 to 66, the 2011 Act being supported by the Coalition Government and steered through Parliament by the Pensions Minister, Liberal Democrat MP, Stephen Webb.

Unfortunately, but the Department for Work and Pensions (DWP) consistently failed to adequately communicate these changes from 2011 despite the Act bringing forward to November 2018 an increased pensions age for women to 65. As a result, tens of thousands of women were plunged into poverty. A recent survey by the WASPI Campaign of its members found that one-in-four affected women struggled to buy food and one third fell into debt. This was an avoidable scandal.

A landmark Ombudsman report in March 2024 told the Government to pay compensation and apologise to 3.6 million, women born in the 1950 's who were affected by the lack of communication in relation to their State Pension age. The report concluded ministers from the Coalition and Conservative Governments failed to properly notify those impacted by the changes.

However, the DWP – under the new Labour Government - has indicated it does not accept the findings of the report. Compensation to up to 3.5m women ranging from £1,000 to £2,950 each would cost between £3.5bn and £10.5bn. A 2006 survey found that 90% of affected women knew about the planned changes in pension age.

Women Against State Pension Inequality (WASPI) calls for fair and fast compensation for the financial and emotional hardship caused by DWP failures. WASPI argues for the highest level of compensation for the worst affected, i.e., women who had the shortest notice of the longest increase to their state pension. The worst affected women received just 18 months' notice of a six-year increase to their state pension age. WASPI continues to call for: All Members of Parliament to support the urgent delivery of fair and fast compensation to all those affected; and compensation scheme proposals should be brought before MPs to vote on as quickly as possible. However, the Ombudsman's report only addressed the issue of communicating the planned changes and did not recommend compensation for the change itself.

This Council notes that more than 11,600 WASPI women across Oldham Borough stand to lose out on compensation after the Labour Government decided to ignore the independent ombudsman's assessment and go against their long-held policy to support WASPI women. It is estimated that the compensation owed to impacted women across Oldham Borough would be a minimum of £11,642,500.

This Council notes that previous Labour Leaders of this Council have referred to the situation facing WASPI women as "an injustice" and as recently as March 2023, Oldham Labour were still campaigning to put that injustice right.

This Council also notes that despite the parlous state of the public finances and scorched earth policy pursued by the previous Conservative Government, the current Labour Government has committed to the 'triple' lock on the state pension which means the state pensions is rising by £470 a year in April 2025.

This Council reasserts its support for the WASPI women and regrets the previous Conservative Government's delay in responding to the Ombudsman's report leaving the decision of incoming Labour government to decide whether the ignore an independent ombudsman's assessment that compensation should be paid to them.

Council resolves to instruct the Chief Executive to write to the Secretary of State for Work and Pensions Right Hon Liz Kendall MP asking her to look again at this decision.

Council further resolves to instruct the Chief Executive to write to the three MPs who represent Oldham Borough as well as the Greater Manchester Mayor Andy Burnham, calling on them to publicly support justice for WASPI women.

Chief Executive	1 The Council launched a pension credit campaign in early October. The focus of the campaign is threefold – increasing awareness amongst potential claimants and their friends and family, reducing any stigmas of claiming and to support residents to make an application ahead of the cut-off to claim Winter Fuel Allowance on 21 December. Over 5000 leaflets have been distributed to council and partner organisations and have been placed in buildings including Libraries, Town Halls and GP surgeries. We have also posted key campaign materials on social media channels, targeted at those over pension credit age. 2. In November the Council and Age UK jointly wrote to 179 residents who from our records were likely eligible to receive pension credit and 309 within £1k above the threshold for claiming. The council's Welfare Rights Team have provided training on pension credits to Action Together. In late November to early December the council's Helpline team made a follow-up phone call to each resident who received a letter. The Helpline team asked whether a resident had received a letter and provided additional information about claiming. They made referrals into our District Teams who have provided one to one home visits to complete an application with a resident. Thank you for your letter of 14 February to the Home Secretary regarding Oldham Council's request for a national public inquiry into child sexual exploitation. I am replying as the Minister for Safeguarding and Violence Against Women and Girls and I am sorry for the delay.

Thank you for sharing the requests of Oldham Council, as agreed in your Council meeting on 12 February. I am aware that the Home Secretary has since written to you on 12 March setting out her commitment to tackling child sexual exploitation and abuse (CSEA) and her support for Oldham's decision to lead an independent local inquiry. As the Home Secretary outlined in her letter on 12 March, the Government has set out funding to support local inquiries and help strengthen local responses to CSEA. I am pleased that the Home Office will be making a direct award to Oldham Council, contingent upon your support in identifying and adopting the best practice principles outlined in our developing framework.

I understand that your work to set up an inquiry is progressing, and the Council has appointed an independent chair since we last met in February. I share the Home Secretary's support for Oldham Council, and my officials and I will continue engaging with the Council as you progress your inquiry.

As you have mentioned in your letter, accountability mechanisms are important for effective local inquiries. The Home Secretary explained that the Government is drawing up a Duty of Candour as part of the Hillsborough Law. We are committed to strengthening the accountability mechanisms that can support and follow up local inquiries, ensuring that those who are complicit in cover-ups or who try to resist scrutiny are always robustly held to account and truth and justice are never denied. I would like to reiterate the offer made by the Home Secretary that our officials would be happy to engage with you to ensure shared understanding of expectations around candour.

You will also be aware that the Home Secretary has appointed Baroness Louise Casey to lead a national audit of existing evidence of group-based child sexual exploitation offending in order to gain a comprehensive national understanding of the scale, nature and characteristics of these crimes. The audit is well underway and will report back in due

course. I understand that Oldham Council may be disappointed that the Government has not commissioned a national inquiry. However, victims and survivors have expressed that they want to see action now, and we know that effective local inquiries can delve into far more local detail and deliver more locally-relevant answers and change than a lengthy nationwide inquiry can provide.

Thank you again for sharing the views of Oldham Council, and I would also like to express my thanks for your leadership in this vitally important area. I look forward to continuing to engage with the Council as you progress your inquiry.
