#### **Purpose of the Report**

## **1 Background**

- 1.1 Safeguarding partnerships produce an annual report because it is a statutory duty designed to ensure transparency, accountability, reflection, and continuous improvement in how children are safeguarded locally and nationally
- 1.2 The Oldham Safeguarding Children Partnership Annual Report has been developed based on evidence, activity, impact, progress and priorities for 2025- 2026. All information contained in the report has been provided by statutory and relevant partners.
- 1.3 The report feeds into national analysis commissioned by the Department for Education to understand trends, assess implementation of Working Together, and identify good practice across England.

## **2 Current position**

- 2.1 The report has been shared with all statutory and relevant agencies who contributed to the final report. These groups are expected to use the report to understand performance, learning, and their contributions to multi-agency safeguarding work. The final report has also been shared with The Department for Education as part of the accountability framework.
- 2.2 The report is published on the OSCP website and is accessible to children, families and carers. Safeguarding Children Partnerships are required to publish their annual report, meaning it must be made publicly available and shared with a wide range of stakeholders.
- 2.3 The report reflects how the vision and values of the Safeguarding Partnership have been woven into the activity of partners and their connections to operational practices through subgroups, audit cycles and training. The report further outlines how the partnership has learnt from serious incidents, practice reviews and how national learning has been embedded.
