3. PURPOSE OF DECISION

Approval is required to fund the associated cost of refurbishment works to Alexandra Park Boathouse WC facility from the Corporate Landlord Capital Budget. The proposed work has been estimated at £55,000. The proposed refurbishment work includes reconfiguration of the facility and creating access between the WC and adjoining Café to enable controlled access and use.
