1. **TITLE:** Arundel Street Muga Installation
2. **SERVICE AREA:** Environmental Services
3. **PURPOSE OF DECISION**

The reason for this report is to request approval to procure and award a contract for the installation of a Multi-Use Games Area (MUGA) at Arundel Street Park in accordance with the Council's Contract Procedure Rules.

The MUGA which needs to be installed has already been purchased and supplied by IAE. As a result of the topography of the site, there are extensive levelling works that need to take place prior to the installation, the levels on site need to be lifted significantly to make this a usable MUGA space. This will be done by introducing a flag on edge curb.

Arundel street park currently has a Striker Goal end with football goal and basketball hoop. By installing sides and a mirrored end, this will enable matches to take place and improve the current play offer in the area.

The required installation work will be funded by the Big Local and a LIF bid from Oldham Council
