LICENSING PANEL - ORDER OF PROCEEDINGS

The procedure outlined below, which was enclosed with the notice of hearing sent to each party, and a copy of which is before you today, will be followed.

Documentary evidence may be relied upon and considered by the Panel if it has been served on the Licensing Authority prior to the hearing, or if all parties consent it can be produced on the day of the hearing.

Any person wishing to call a witness to speak at the hearing must have applied in writing for permission from the Licensing Authority at least 2 working days before the hearing and must also have provided the name of the witness and a brief description of the points on which that person may be able to assist the authority in relation to their application, representations or notice. Any application to call a witness where the party has not given 2 working days' notice will be considered by the Panel at the beginning of the hearing and permission will not be unreasonably withheld.

Each party will have the same amount of time in which to address the Panel, each party will have up to 60 minutes to address the authority and give any further information (which must be relevant to that party's or another party's application or representation). Where any party considers this time to be insufficient then, a request in writing may be made to the Constitutional Services Officer for an extension of time at least two working days before the hearing; however this will not automatically be granted, and will be at the discretion of the Panel.

Any person behaving in a disruptive manner will be asked to leave the hearing, however, if this occurs that person will be entitled to submit in writing any information they would have been entitled to give orally.

The Authority will provide a record of the hearing in a permanent and intelligible form and keep it for 6 years from the date of determination or disposal of any Appeal.

Members are advised that they are making decisions in a quasi-judicial manner. As such, they have a duty to view all evidence presented before them impartially. Members must disregard any information given by a party which is not relevant to the promotion of the licensing objectives. The Panel is not bound by the formal rules of evidence. Nevertheless, Members must carry out their duty placing what weight they feel is appropriate given the nature of the evidence and the manner in which it was obtained, and communicated.

ORDER OF PROCEEDINGS

INTRODUCTION

The Constitutional Services Officer ("the Clerk") will welcome those present and outline the procedure to be followed (as set out below) and record those present. The Clerk will remind everyone that each party will have up to 60 minutes to address the Panel and give any further information.

APPLICATION

The Licensing Officer will outline the nature of the application.

The applicant and/or their representative to address the Panel, present additional information in support of the application (where consent to do so has been granted) and call any witnesses (subject to having given the required prior notice or having received permission at the beginning of the hearing). The Applicant and any witnesses may be questioned by Members of the Panel.

Any party, if given permission by the panel, may question the applicant and his witnesses, but this shall not take the form of cross examination.

REPRESENTATIONS

The Party making the representation and/or their representative to address the members of the Panel, providing any additional information in support of their representation (where consent to do so has been granted) and call any witnesses (subject to having given the required prior notice or having received permission at the beginning of the hearing). The party and any witnesses may be questioned by Members of the Panel.

In the event that a number of members of the public are present at the meeting who intend to make a representation in relation to the application as interested parties then the Chair has discretion to ask that they appoint a nominated spokesperson to present their representations.

Any party, if given permission by the panel, may question the party making representations and his witnesses, but this shall not take the form of cross examination.

These representations will be taken in the following order: -

- Police Representation (unless they are the applicant)
- Licensing Authority
- Environmental Health Representation
- Other Responsible Authorities Representation
- Public Representation (Interested Parties)

2. Recommendations

5. Licensing Policy

- 5.2 A full copy of the Councils Licensing Policy Statement will be available at the hearing.

- 7.3 In arriving at a decision Members must have regard to the relevant provisions of national guidance and the licensing policy statement and reasons must be given for any departure.
- 7.4 The decision should be based on the individual merits of the application.

8.1 Consultation in accordance with the Act has taken place with all responsible bodies and notice has been given to allow for any representations from interested parties.



General

For sale by retail of alcohol, Coldhurst off licence has in place an effective and responsible management for its premises, providing adequate training to staff by myself as the designated premises supervisor. The licensing objectives have been taken into consideration, the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm. Insuring in protecting the public and local residents from crime, anti-social behavior and noise nuisance.

The training programmed will also include preventing sale of alcohol and keeping records of any incident, sale or refusal to an underage (that is under 18 or appears to be under 18), and persons who are drunk.

Staff that sell alcohol on the premises, copies of their identification would be kept on the premises, upon request of any responsible authority as an example giving the police and licensing authorities the powers they need to effectively manage and police the night-time economy.

The main supplier of alcohol to Coldhurst off licence would be Booker cash & carry, all sales invoices of alcohol would be available upon request by the licence authority.

The Prevention of Crime and Disorder

Coldhurst off licence has installed the most up to date CCTV system available on the market. This tamper proof system has 24-hour recording in high definition. The footage of six cameras would be available 28 days. All potential vulnerable areas in the store and entrance and exit will provide a clear head and shoulder to an evidential quality. Recorded footage will be provided upon request of any responsible authority. Sufficient storage and software would be kept near the CCTV box, to supply evidence upon request.

Signage informing potential customers that CCTV is in operation would be placed in prominent positions within the Coldhurst Store. Written documentations of checks and training, signed off by myself as the designated premises supervisor would be available upon request by the relevant authority.

I, Taj Ahmed as the designated premises supervisor is the key person who will be responsible for the day to day business activities. Competent management will reduce a rise to issues of crime and disorder and public safety.

Public Safety

At Coldhurst off licence, a fire risk has been assessment has been carried out and documented. The store would hold two Co2 fire extinguishers are class B, containing carbon dioxide, a clean extinguisher that leaves no residue, flammable liquid suitable for alcohol and live electrical equipment.

All exit routes and doors on such routes shall will be checked on every occasion before the premises is open for trade and checks on regular occasions when the premises are open to the public to ensure it is free from defect, obstruction, trip hazards and surfaces are not slippery. A record of inspections, of any defects discovered and the corrective action taken shall be provided in a logbook kept for that purpose. That logbook shall be made available for inspection on demand to an authorised officer of the council, a fire officer or the police.

A first Aid box will be kept on the premises for both staff and customers, in any incident should occur it will be documented in the incident book, kept on the premises ready for inspection of the relevant authority.

The Prevention of Public Nuisance

Coldhurst off licence will prominently place clear and legible notices displaying at the exit requesting the customer to respect the needs of local residents and to leave the premises and the area quietly. Myself as the designated supervisor will ensure that staff who arrive early morning or depart late at night when the business has ceased trading conduct themselves in such a manner to avoid causing disturbance to nearby residents

The movement of bins and rubbish outside the premises will be kept to a minimum after 11.00pm. This will help to reduce the levels of noise produced by the store. All the rubbish produced by the store will be stored securely in a designated area with a tight fitting lid. This will help prevent litter being blown around. The placing of refuse, such as boxes, into receptacles outside the premises will take place at times that will prevent disturbance to nearby properties.

Coldhurst off licence waste collection is contracted to a specialist contractor Biffa, making sure that there are enough storage facilities for waste, fully contained and a lockable bin, which will be thoroughly cleaned and kept away from public areas.

Coldhurst off licence is allocated on an end terrace, prevention of public nuisance is not an issue. Staff arrive and when leave at the end of the shift are trained to avoid causing disruption to the nearby residents. Deliveries to the store will be arranged around 11am to further prevent nuisance or disturbance to the nearby residents. Both lights in and outside the premises will be positioned deliberately, directing light downwards not to cause a disturbance to nearby residents.

The Protection of Children from Harm

Coldhurst off licence recognise the protection of children from harm includes the protection of children from moral, psychological and physical harm. It is completely unacceptable to sell alcohol to children. Conditions relating to the access of alcohol to children has been carefully considered. The premises will have clear signs displayed for restricting people under 18 years.


Coldhurst off licence will operate a proof of age policy, as the licence holder, an age verification policy has been placed to the premises in relation to the sale of alcohol. Challenge 25 is the strategy, anyone who is over 18 but looks under 25 to carry acceptable identification such as, a card bearing the PASS hologram, a photographic driving license or a passport.

Posters will be placed in prominent places in the store to advertise that Challenge 25 is operational. This helps not only to deter potential underage customers, but also acts as a back up to staff members who make challenges. Training will provide staff to have confidence that the decisions they make will not be undermined by management.


A must as a minimum requirement to individuals who appear under the age of 18 years of age, to a responsible person to produce identification on request, also staff who are involved in the supply of alcohol are aware of the existence and content of the age verification policy applied by Coldhurst Off licence.

Challenge 25 encourages the keeping of records of all the failed attempts to buy alcohol of those without ID who look under 25, this helps licences with relevant authorities. Keeping records developed to reinforce the message throughout store, that people who are attempting to buy alcohol and who look under 25, will be asked for ID. The signage, in red and black, adds a fresh and striking look and makes it clear that under 25s must now expect to be challenged to prove their age, before sale of alcohol.

We are writing, as a recognised Islamic establishment on the same road and representing a community in excess of four hundred people, to express our grave concerns and fears of the repercussions to the proposed licensing of the above premises.

We feel that enabling an alcohol license would further increase the crime and disorder of this area as alcohol becomes more readily available and the associated anti-social behaviour particularly in the youths. Oldham has already experienced a 60% crime rate increase in the last 3 years (https://www.numbeo.com/crime/in/Oldham) and couple that with the 35% loss of officers in the Greater Manchester area alone, we are afraid that issuing a license would mean more anti-social behaviour and no Police officers to deal with it as demonstrated all around Oldham with violent off licenses robberies due to alcohol.

We therefore believe that this would have devastating effects on children and youth and the quality of life in the area as it would attract more crime and anti-social behaviour.

We also believe that the negative impact on health that access to alcohol will have. Public Health England have said that nine of the region's ten boroughs have a higher rate of alcohol related deaths than the national average. Greater Manchester Health Partnership said it knows "that drugs and alcohol adversely affect our people, our communities and our public services more than in most other places in England". (Oldham Chronicle.co.uk). We feel that a license would bring further issues to a community already deprived and feeling the after effects of a particularly troublesome two year period of Covid.

We would also ask for you to have a Community Consultation before granting of an alcohol license.

I do hope you take our letter and reasons for refusal of an alcohol license seriously as it will be us, the people who live, work and worship in the area to face the effects of it

Sir/Madam,

I am writing to you regarding the application for a premises licence for the properties of 162 Chadderton Way (Coldhurst Off Licence, OL1 2EW) which would enable the premises to sell alcohol.

I would like to lodge my objection to granting of yet more alcohol licence in this neighbourhood. I believe it will significantly increase public nuisance and be a threat to the safety of the general public. This off licence is also very close to two recently opened children play parks (on Martha St. and Ripon St.) where children play.

May I also point out (without making this a race issue), this being a predominantly Asian neighbourhood, there aren't many alcohol-consuming customers except young Asian kids whom the parents are desperately trying to keep away from drugs and alcohol these days. And the last thing they need is a shop on the doorstep selling alcohol.

There are, however, some existing premises in the neighbourhood to cater to anyone wishing to purchase alcohol. There's an off licence at 284 Rochdale Rd. as well as Tesco Chadderton (which is just across the road).

I would like to reassure you that I am not anti-business. We all understand that high unemployment and crimes are directly related. For a town/neighbourhood or city to prosper and become a pleasant place for its residents to live in, it should have good employment opportunities. More people working means they will have more disposable income to spend in local businesses which in turn will create more jobs. Sadly, we already have a high crime rate and high drug-related problem in this neighbourhood.

About 4 weeks ago, in the evening when I went out for a walk, I was abused by a young Asian lad on Ripon St. The lad was drunk, he verbally abused me and came to attack me but I managed to quickly extricate myself before he could attack. I know the lad, I know his entire family and he knows me too. Yet when he was drunk he behaved in ways he would never do normally. Some days later his dad came to apologise.

Sadly, this kind of incidents are on the rise and it is now quite dangerous to be driving around in this area as young kids, mostly drunk and on drugs, drive around menacingly doing 70, 80, 90mph on a 30 limit road!

I welcome the fact that a new business is opening which will serve the community as well as create one or two jobs. I am sure there are hundreds of items it can sell and still be very profitable. But selling alcohol, particularly which are to be taken outside and consumed outside of the property, sadly, will create too many problems for a neighbourhood which is already struggling with nuisance, noise, littering and crime.

I hope the licencing panel will take all these into consideration and make the right decision.

I believe the last day for any objection regarding this licence is 30/10/21. I am sending this on the evening of 29th Oct. 21.

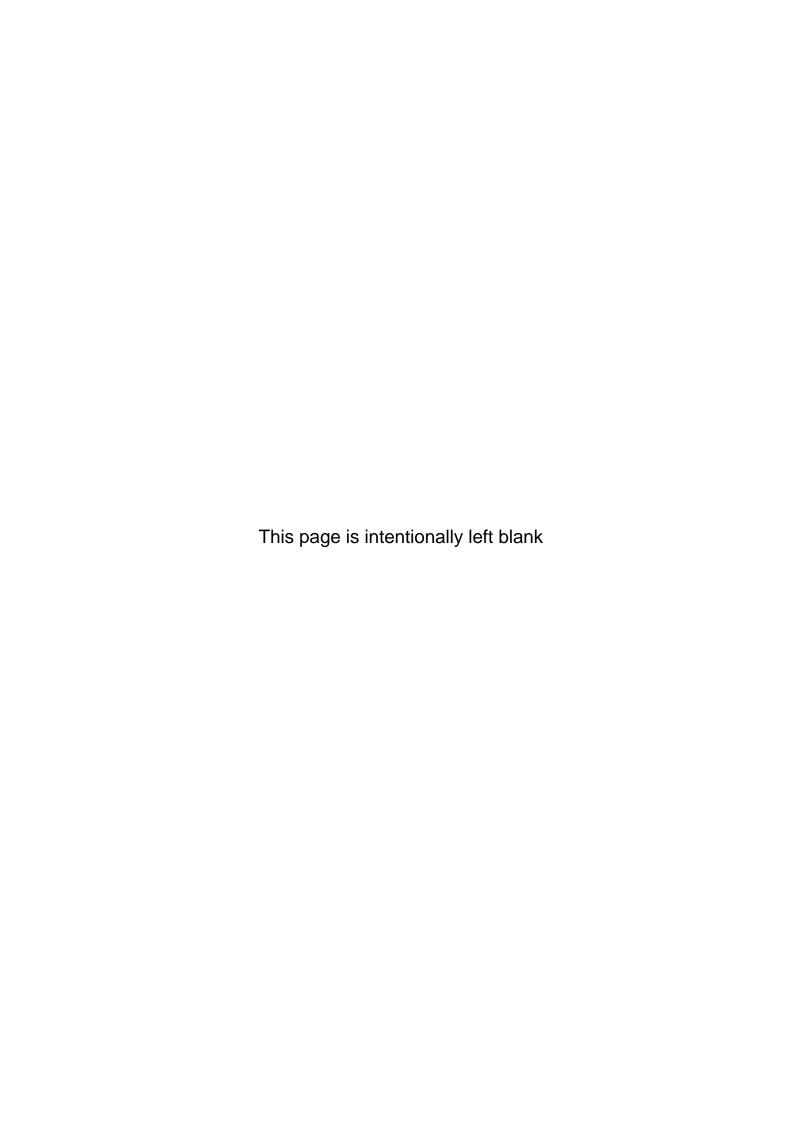
> Hi respected people.
