Reason for Decision

The Local Improvement Fund (LIF) in 2022/23 includes £100,000 allocated as “fast grants” for projects of £500 - £3,500 to improve Oldham’s neighborhoods for the benefit of local residents. After the first round, £72,428 remained available for projects. The LIF Cabinet Sub-Committee are asked to review the final scores and comments provided by the advisory panel and agree which applications should receive funding.

Recommendation

Review the Advisory Panel recommendations and agree which should receive LIF funding.

1 Background

- 1.1 The Local Improvement Fund (LIF) was established in 2019 with the aim of supporting Districts to:
- a. Encourage the active participation of residents and local organisations in improving the quality of life in the local area.
 - b. Improve community buildings, equipment and other facilities.
 - c. Engage with residents to prioritise schemes that matter to them.
- 1.2 In 2019/20 the LIF distributed £499,260 to twenty projects across Oldham that reflected the specific and diverse needs of people in our borough, ranging from an outdoor gym in St Mary's, to making a footbridge safer in Royton, to street scene improvements in Lees.
- 1.3 The LIF was included in the Council's budget again in 2021/22, with £500,000 made available. In 2021/22 a total of £467,807 was allocated to 18 projects across the borough, with the remaining £32,193 retained as a contingency fund to accommodate project overspend. Councillors were asked to focus on projects that would help Oldham's residents to recover from the pandemic.
- 1.4 In 2022/23 the LIF is divided into two, with £400,000 distributed as capital grants as in previous years. The remaining £100,000 is to be used for "fast grants" of between £500 and £3,500, distributed as revenue to support one of three key priorities:
- Helping those adversely impacted by the cost-of-living crisis
 - Providing / improving facilities for children and young people
 - Supporting the Don't Trash Oldham campaign
- 1.5 The £100,000 must be completely allocated in the financial year 2022/23, with bidding for projects taking place over multiple rounds as needed.
- 1.6 In the first round, 22 bids were received with a total value of £49,196. Following a review by a cross-party advisory group, the LIF Cabinet Sub-Committee met on 6th December 2022 and agreed to fund projects worth £27,572, leaving £72,428 available.
- 1.7 One proposal from the first round, requesting funding for the replacement of litter bins in Dogford Park, was recommended for approval by the advisory group but was rejected by the sub-committee. This occurred because of what was subsequently identified as incomplete advice about the availability of alternative funding for the project. It is therefore recommended that this proposal, for the replacement of litter bins in Dogford Park in Royton, be approved for funding in this second round at a cost of £1,860.
- 1.8 Apart from the Dogford Park litter bins application, in the second round 52 applications were included, with a total potential funding value of £146,804. These

applications included new bids and bids that were deferred from the first round pending additional information.

- 1.9 The cross-party advisory group has reviewed these bids and made recommendations as detailed in Appendix 1. Including the Dogford Park litter bin project, the group recommend funding 26 projects with a total value of £71,134.63. This paper asks the Cabinet Sub-Committee to review the bids and the recommendations of the advisory group and allocate funds accordingly.
- 1.10 If the sub-committee accept the advisory group's recommendations there will be £1,293.37 remaining in the funding pot. The advisory group recommend that this remaining funding be used as contingency funding for the approved projects, rather than opening a third round of proposals.

2 Options/Alternatives

- 2.1 Do Nothing – This is not a preferable option as the funding needs to be allocated in this financial year.
- 2.2 Review the advisory group recommendations and agree which should receive LIF funding, including the Dogford Park litter bins proposal from the first round.

3 Recommended Option

- 3.1 Review the advisory group recommendations and agree which should receive LIF funding, including the Dogford Park litter bins proposal from the first round.

4 Financial Implications

- 4.1 There is a set aside of £100,000, which is a one-off revenue resource to be utilized in 2022/23 for LIF fast grants. £27,572 was allocated in the first round.
- 4.2 The second round of applications totaled £146,804 with £71,134.63 recommended to be approved. This would leave a balance to allocate for further rounds of £1,293.37.

Reason for Decision

The Local Improvement Fund (LIF) in 2022/23 includes £400,000 allocated as “capital grants” for projects of £10,000 or more to improve Oldham’s neighborhoods for the benefit of residents. The LIF Cabinet Sub-Committee are asked to review the final scores and comments provided by the advisory panel and agree which applications should receive funding.

Recommendation

Review the Advisory Panel recommendations and agree which should receive LIF Funding.

Reviewing District Working in Oldham

1 Background

- 1.1 In November 2022, Cabinet agreed to include the Local Improvement Fund (LIF) in the Council's budget within the existing capital programme, with £500,000 made available. The LIF is divided into two, with £400,000 distributed as capital grants. The remaining £100,000 is to be used for "fast grants" of between £500 and £3,500. This paper focuses on the administration of the £400,000 capital grants.
- 1.2 The deadline for expressions of interest to the capital fund was 9th December 2022. In total 47 proposals were received. The Advisory Panel were asked to score the applications, using the same scoring matrix as in previous years. This involved rating each element of the bid out of five according to the extent to which the proposal:
- Addresses one or more key priority
 - Has clearly defined aims and objectives
 - Demonstrates the outcomes and benefits clearly
 - Evidences an understanding of project dependencies
 - Evidences resident consultation and support
 - Evidences project costing
- 1.3 The LIF Advisory Panel met in December and scored the expressions of interest, recommending that 31 of the expressions of interest be invited to submit full applications.
- 1.4 The deadline for receiving full applications was Friday 20th January 2023. In total we received 30 full applications for the capital fund.
- 1.5 The LIF advisory panel met in January 2023 and scored the full applications. It was noted that applications 23 and 29 were duplicates, so 23 was disregarded at the start the meeting. Following the moderation of scores, the panel agreed that anything scoring over 23 should automatically go through to the sub-committee. Anything that scored under 20 was automatically rejected. The panel then had a conversation about any application that scored between 20 – 23, rejecting or recommending the applications based on their collective analysis.
- 1.6 The Advisory Panel's recommendations and comments are included in Appendix 1. Please note, 16 applications have been recommended by the advisory panel totalling £410,735 of spend, with three projects recommended as potential reserves (highlighted in orange), totalling an additional £40,826 and taking the overall total to £451,561.
- 1.7 The LIF Cabinet Sub-Committee are asked to review the final recommendations and comments provided by the advisory panel and agree which applications should receive LIF funding, totalling no more than £400k.

2 Options/Alternatives

- 2.1 Do Nothing – This is not a preferable option as the funding needs to be allocated in this financial year.
- 2.2 Review the full Advisory Panel recommendations and agree which should receive LIF Funding – The purpose of the LIF is to support district priorities, allocating funding to projects that demonstrate they meet the required scoring criteria.

3 Recommended Option

- 3.1 Review the Advisory Panel recommendations and agree which should receive LIF Funding.

4 Financial Implications

- 4.1 The Capital Programme includes £0.400m to support the Local Improvement Fund for Districts as outlined in this report. Funding requests of £0.411m are recommended for approval, along with a reserve set of schemes of £0.041m subject to scheme amendments.
- 4.2 The recommended approach would exceed the funding available by £0.011m and the report does not identify a funding stream for the shortfall. As the scheme costs are based on estimates there may well be some underspending within the proposed schemes which would accommodate the approval of all of the recommended schemes. In addition, there may be some underspend from previously approved schemes. Officers will need to reconcile all prior year approval of grants in order to determine the scope of resources available. The schemes recommended in this report will be subject to close monitoring in order to ensure that there is no additional budgetary pressure
- 4.3 Given the funding allocation available, there should be no firm commitment to the £0.041m of schemes on the reserve list. The position might change if resources can be identified.
- 4.4 Colleagues are reminded that expenditure on all approved schemes must meet the statutory definition of expenditure for capital purposes. (Jit Kara)
