LICENSING PANEL - ORDER OF PROCEEDINGS

The procedure outlined below, which was enclosed with the notice of hearing sent to each party, and a copy of which is before you today, will be followed.

Documentary evidence may be relied upon and considered by the Panel if it has been served on the Licensing Authority prior to the hearing, or if all parties consent it can be produced on the day of the hearing.

Any person wishing to call a witness to speak at the hearing must have applied in writing for permission from the Licensing Authority at least 2 working days before the hearing and must also have provided the name of the witness and a brief description of the points on which that person may be able to assist the authority in relation to their application, representations or notice. Any application to call a witness where the party has not given 2 working days' notice will be considered by the Panel at the beginning of the hearing and permission will not be unreasonably withheld.

Each party will have the same amount of time in which to address the Panel, each party will have up to 60 minutes to address the authority and give any further information (which must be relevant to that party's or another party's application or representation). Where any party considers this time to be insufficient then, a request in writing may be made to the Constitutional Services Officer for an extension of time at least two working days before the hearing; however this will not automatically be granted, and will be at the discretion of the Panel.

Any person behaving in a disruptive manner will be asked to leave the hearing, however, if this occurs that person will be entitled to submit in writing any information they would have been entitled to give orally.

The Authority will provide a record of the hearing in a permanent and intelligible form and keep it for 6 years from the date of determination or disposal of any Appeal.

Members are advised that they are making decisions in a quasi-judicial manner. As such, they have a duty to view all evidence presented before them impartially. Members must disregard any information given by a party which is not relevant to the promotion of the licensing objectives. The Panel is not bound by the formal rules of evidence. Nevertheless, Members must carry out their duty placing what weight they feel is appropriate given the nature of the evidence and the manner in which it was obtained, and communicated.

ORDER OF PROCEEDINGS

INTRODUCTION

The Chair will welcome those present and outline the procedure to be followed (as set out below) and the Clerk will record those present. The Clerk will remind everyone that each party will have up to 60 minutes to address the Panel and give any further information.

APPLICATION

The Licensing Officer will outline the nature of the application.

The applicant and/or their representative to address the Panel, present additional information in support of the application (where consent to do so has been granted) and call any witnesses (subject to having given the required prior notice or having received permission at the beginning of the hearing). The Applicant and any witnesses may be questioned by Members of the Panel.

Any party, if given permission by the panel, may question the applicant and his witnesses, but this shall not take the form of cross examination.

REPRESENTATIONS

The Party making the representation and/or their representative to address the members of the Panel, providing any additional information in support of their representation (where consent to do so has been granted) and call any witnesses (subject to having given the required prior notice or having received permission at the beginning of the hearing). The party and any witnesses may be questioned by Members of the Panel.

In the event that a number of members of the public are present at the meeting who intend to make a representation in relation to the application as interested parties then the Chair has discretion to ask that they appoint a nominated spokesperson to present their representations.

Any party, if given permission by the panel, may question the party making representations and his witnesses, but this shall not take the form of cross examination.

- Licensing Authority
- Environmental Health Representation
- Other Responsible Authorities Representation
- Public Representation (Interested Parties)

1. Purpose of Report

1.1 The purpose of this report is to inform members of an application for the grant of a premises licence in respect of Albion Farm/Turkey Shed, Oldham Road, Delph, Oldham, OL3 5RQ which, due to representations being received, has been referred to this Panel for determination.

2. The Application

- 2.1 On the 8 August 2025 the applicant, Jac Billington, applied for the grant of a premises licence for the Albion Farm/Turkey Shed. The last date for representations in relation to this application was 5 September 2025.

- 2.5 A copy of the application is attached at **Appendix 13.1** and proposed plans are attached at **Appendix 13.2** and 13.3.
- 2.6 A location map is attached at Appendix 13.4.

3. Representations

- 3.1 Following submission and advertisement of the application, representations were received. These are set out at **Appendices 13.5 to 13.21** of the report. Two of the respondents (Appendices 13.7 and 13.8) provided video evidence via WhatsApp. This evidence can be made available to members upon request.
- 3.2 It should also be noted that following consultation with **Greater Manchester Police** their representation was withdrawn when the applicant agreed to incorporate the following amendments to requested hours, and revised conditions on the premises licence.

GMP would suggest the extra conditions set out below to cover the outdoor events to assist the prevention of crime and disorder, prevention of public nuisance and public safety licensing objectives.

Extra conditions regarding special outdoor events will contain:

SPECIAL EVENTS

Albion Farm/Turkey Shed has the facility to put on special events during the year. These events will involve the use of the outside area of the Albion Farm and Turkey Shed.

1. Event Management Plan

An Event Management Plan must be produced and forwarded to the Licensing Office for circulation to the responsible authorities a minimum of 28 days before the date of the activity. The event management plan must include appropriate risk assessments to be agreed to by all responsible authorities before the event can go ahead.

The applicant must submit an event notification form to the council at least 4 weeks before the event if they are to attract more than 200 people to the event.

2. Permitted numbers

The maximum number of people attending an event including staff, security and stewards will be 499

3. Notice period

Albion Farm/Turkey Shed will notify the police and local authority that any such event is being held at least 28 clear days before such an event. Not including the day that the notice is given or the day of the event.

4. Notice to residents

Residents will be notified by letter at least 28 clear days before such an event. Not including the day that the notice is given or the day of the event. The letter will include details of the event and details of a point of contact for Albion Farm/Turkey Shed who will be on duty on the day of the event including a telephone number.

5. Perimeter Inspections

The Designated Premises Supervisor must ensure that perimeter inspections are undertaken every hour when regulated entertainment, live music (amplified or unamplified) is taking place recorded music or any other type of entertainment (amplified or unamplified) is taking place These inspections must be recorded in a book which must be made available for inspection to Local Authority Officers and Greater Manchester Police on request.

6. Music cut off time

Any external music, live or recorded will cease no later than 2200 hours.

7. Security

Each event as a minimum will employ 2 SIA registered door staff. All door staff will wear hivisibility vests/jackets so that they can be easily identifiable to the public and emergency services if required.

8. Door Staff Log

A Door Supervisor Log shall be correctly maintained at the premises. This will include the following details:

- (i) The door staff names, dates of birth and home addresses.
- (ii) Full details, name, address and contact number of employment agency used And for each individual period of trading:
- (iii) The name of the individual member of door staff
- (iv) His/her Security Industry Authority licence number
- (v) The time and date He/she start and finishes duty
- (vi) The time of any breaks taken whilst on duty
- (vii) Each entry shall be signed by the door supervisor and DPS or nominated person

9. Event search policy

Albion Farm/Turkey Shed must implement and document a search policy for each event. Those suspected of carrying offensive weapons/drugs will be excluded from the premises.

10. Litter Control

The Designated Premises Supervisor must ensure that a member of staff collects all litter from within the curtilage of the premises after each event. A written log must be kept of the areas checked and made available to responsible authorities for inspection on request.

11. First aid

There must always be a minimum of 2 suitably trained and qualified first aid staff on duty during an event. They must wear a hi-visibility vest/jacket and be clearly identifiable to the public or emergency services if required.

12. External Use of Polycarbonate Glassware

All glassware used in the outside area of the premises must be of Polycarbonate type. Any drinks served in bottles must be in plastic bottles only. All drinks from glass bottles to be decanted into polycarbonate containers.


13. Personal Licence Holder

A Personal Licence Holder must always be present at the premises whilst a special event is taking place.

3.3 It should also be noted that following consultation with **Environmental Health** their representation was withdrawn when the applicant agreed to incorporate the following amendments to requested hours, and revised conditions on the premises licence.

Recorded music outdoors finishes by 9.00pm every night and that the other outdoor events such as live music, folk dancing and dance are limited to four events per year and must finish by 11.00pm.

3.4 The applicant, Mr. Billington, engaged the services of a Licensing Consultant, Mr. Tony Dales of Due Diligence Matters. Mr. Dales requested that a revised proposal of timings, to replace the original application, be submitted to panel members. This revised proposal is attached at **Appendix 13.22**. As the proposal differs from the terms previously agreed, it has been sent to Environmental Health and GMP to give them the opportunity either to maintain their withdrawal of representation or to reinstate their original representation for





3.5 A copy of the revised proposals of timings has also been circulated to all other parties who submitted representations.

4. Licensing Policy

- 4.1 Members considering this application should take note of the Authority's Licensing Policy. Attention should be drawn to page 7, Prevention of Crime and Disorder, and page 11, Public Safety, and page 13, Prevention of Public Nuisance and page 15, Protection of Children from Harm.
- 4.2 In relation to 'Public Nuisance' the following paragraph(s) provide:-

When addressing public nuisance, the applicant should initially identify any particular issues (having regard to their particular type of premises and/or activities), which are likely to adversely affect the promotion of the public nuisance objective. Such steps as are required to deal with these identified issues should be included within the applicants operating schedule.

If relevant representations are received, the Authority may impose conditions to prevent nuisance, noise, disturbance, light pollution, noxious smells, vermin and pest infestations and accumulations of rubbish and litter.

Conditions may include restrictions on the times when music or other licensable activities may take place and may include technical restrictions on sound levels at the premises. Conditions may be imposed requiring licensees to display signs at all exits of premises reminding customers to leave premises quietly and to respect the rights of nearby residents.

4.3 A full copy of the Councils Licensing Policy Statement will be available at the hearing.

5. Secretary of State's Guidance

- 5.1 Members also need to consider statutory guidance issued, by the Secretary of State, under Section 182 of the Licensing Act 2003 (February 2025).
- 5.2 Chapter 2 of the guidelines deals with the Licensing Objectives and potential measures licence holders and the licensing authority should consider so they are not being undermined.

In relation to 'Crime & Disorder' the following paragraph(s) provide:

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.3 Conditions should be targeted on deterrence and preventing crime and disorder...For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are

properly covered and there is no subsequent dispute over the terms of the condition.



In relation to 'Public Safety', the following paragraph provide:-

- 2.16 Licence holders should make provision to ensure that premises users safely leave their premises. Measures that may assist include:
 - Providing information on the premises of local taxi companies who can provide safe transportation home; and
 - Ensuring adequate lighting outside the premises, particularly on paths leading to and from the premises and in car parks.

In relation to 'Public Nuisance', the following paragraphs provide:-

- 2.25 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11pm and 8am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.
- 2.27 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in antisocial behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises and to respect the rights of people living nearby to a peaceful night.

In relation to 'Protecting of children from harm', the following paragraphs provide:-

- 2.28 The protection of children from harm includes the protection of children from moral, psychological, and physical harm. This includes not only protecting children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.
- 2.32 Licensing authorities and responsible authorities should expect applicants, when preparing an operating schedule or club operating schedule, to set out the steps to be taken to protect children from harm when on the premises.
- 5.3 A full copy of the guidance will be available at the hearing.
- 6. Options

- 6.1 When determining the application Members, having had regard to the representations, may take such steps as they consider appropriate for the promotion of the licensing objectives. The steps available to Members are:
 - a. Grant the application as applied for with or without the amendments agreed with Greater Manchester Police and Environmental Health.
 - b. Grant the application but modify the operating schedule in relation to hours, days, conditions, or activities.
 - c. Reject the application.
- 6.2 Any steps appropriate to promote the licensing objectives should be specified. If none of the steps are appropriate and proportionate, no action should be taken.
- 6.3 In arriving at a decision Members must have regard to the relevant provisions of national guidance and the licensing policy statement and reasons must be given for any departure.
- 6.4 The decision should be based on the individual merits of the application.

7. Consultation

7.1 Consultation in accordance with the Act has taken place with all responsible bodies and notice has been given to allow for any representations from interested parties.

8. Legal Services Comments

- 8.1 In determining the application Member should have regard to the Authority's licensing policy statement and the Secretary of State's Guidance. The applicant or any other person who made relevant representations in relation to the application have a right of appeal to the Magistrates' court (A.Evans).
- 9. Environmental and Health & Safety Implications
- 9.1 Contained within the body of the report.
- 10. Equality, Community Cohesion & Crime Implications
- 10.1 The Councils Statement of Licensing Policy considers these matters. All decisions made by the Licensing Panel must have regard to this policy and national guidance.








The requested permissions to play amplified music outdoors until very late will significantly disrupt my family's daily routine and wellbeing. Outdoor music carries much further than indoor entertainment, and my children need quiet evening hours for rest and sleep. My partner and I require a peaceful home environment after long working days. The combination of outdoor amplification and extended music hours will make it difficult for us to maintain a normal family life in what should be our sanctuary. I also suffer from insomnia, which has a huge impact on my mental health, where any night-time disruption from outdoor music can cause long-lasting implications.

Supporting Evidence: As a working parent, I can attest that the premises is located in a family-oriented residential area where we have chosen to raise our children specifically because of its peaceful character. Outdoor music with extended hours will:

- Disrupt my children's sleep schedules and ability to concentrate on education due to the increased noise transmission from outdoor speakers
- Prevent normal family activities like bedtime routines and quiet evening time together as outdoor music cannot be contained like indoor entertainment
- Create stress for my partner and myself as we try to maintain a stable home environment against unavoidable outdoor noise

- Impact our ability to rest after demanding work schedules, as outdoor music travels directly into our living spaces
- Undermine the family-friendly nature of our neighbourhood that drew us here by introducing significant outdoor noise pollution

The outdoor nature of this music application, combined with extending hours, will make our way of life significantly worse for my family.

It's important to note that this is a quiet rural/residential setting, not a bustling town centre where outdoor entertainment venues are commonplace. Unlike dense urban high streets where buildings naturally contain and absorb sound, our open rural environment allows sound waves to travel much further and with greater intensity. The lack of natural sound barriers means that outdoor music from these premises will carry directly into family homes across a wide area, creating a level of disturbance that would be unacceptable in a residential community that residents chose specifically for its tranquil character.

If the new license is granted, this will occur later, and in to the early hours of the morning and in greater numbers. The potential for crime and nuisance to the local neighbours is high. There are also very limited public transport facilities in the area, actually none in the early hours, increasing the likelihood of drink driving from the venue. The area in which the Turkey Shed is situated, is a rural area. We, and most other residents moved to the area for the tranquillity, peace and natural atmosphere of the surroundings. Live, amplified music and the revellers attending such activities would be impossible to contain within the geographical area, which is in a valley, in which sounds echo. We can categorically attest to this as The Turkey Shed held an event on 20th June, either licensed or not, which meant that even speaking to family within our own garden necessitated raising our voices to properly hear each other. The music and shouting of the attendees could be heard indoors, even with doors and windows closed. The application to play music at these times, with the potential for it to happen up to 7 days a week is deeply inappropriate in such a rural area with residential properties so close. Residents in the surrounding area moved here with the reasonable expectation of peace and tranquillity. This proposal threatens to fundamentally alter the rural character of the area and infringe on residents' rights to the peaceful enjoyment of their homes, contrary to Article 8 of the European Convention on Human Rights.

Lack of Mitigation and Unsuitability of Venue.

We have grave concerns about this application due to the lack of acoustic screening or sound limiting equipment. The surrounding area is not conducive to this. As the license request if for outdoors, and on a farm, the audience numbers could potentially be extensive. We also have huge concerns about the frequency of events. In the summer, we could potentially be subjected to this nuisance, every day of the week for months. This is wholly unacceptable.

A farm shop in a rural location, designed for daytime retail and agricultural use is simply not a suitable venue for high-volume entertainment extending into the early morning. Allowing this would set a dangerous precedent for similar non-purpose-built venues in residential rural communities.

Outdoor amplified sound into the early hours poses a significant risk of statutory nuisance, as defined in the Environmental Protection Act 1990. Night-time noise has well-documented negative impacts on sleep, mental health, and general wellbeing, particularly in quiet rural areas where background noise levels are very low.

Licensing Objectives

This representation is on behalf of myself, Marie Woodhead and my husband, Colin Woodhead. We are long-standing residents — my husband is 78 and I am 74. We have worked hard all our lives and want to enjoy a peaceful retirement. I feel compelled to raise my concerns about the proposal to allow outdoor activities such as showing films, playing live and recorded music, and having dance events at The Turkey Shed. At my stage of life, peace and stability are not luxuries but necessities, and this application threatens both.

The Prevention of Crime & Disorder

Please state the reasons you believe granting the application will undermine this objective A matter of real unease is the way people gather in and around the car park in the evenings and at night when the weather is nice. On one occasion this year when it was warm and sunny, a group of young men moved a picinic table to the top end of the carpark and situated themselves behind a large skip which I could see directly opposite my house. They were extremely loud, drunk, rowdy and swearing and I could clearly hear them despite only having my kitchen window open. If the venue is allowed to expand into a licensed outdoor music space, visitor numbers will grow and with them the risk of more disorder. For older residents like ourselves, the prospect of groups sitting outside and being rowdy as well as potentially leaving leaving noisily in the early hours is especially unsettling. The noise travels straight across to my house and is extremely disruptive.

The Prevention of Public Nuisance

Please state the reasons you believe granting the application will undermine this objective Thurston Clough Road has always been valued as a quiet corner of the village. Noise travels easily across the field, and when music is amplified outdoors it carries far further than the venue itself. Evenings and weekends are the times when residents, myself included, most need rest, peace and quiet, and it is exactly then that the impact would be greatest.

We already have first-hand evidence of what this means in practice. On a hot, sunny Friday evening on 20th June 2025, the venue staged a singer outdoors. I was sitting outside reading a book when the singing started. From my garden, the noise was incredibly loud. I have recordings of it which I will attach. I had to move indoors and then the noise was still overbearing — even with only 1 window open. I then shut all the windows and could still hear the singer. Several of our neighbours raised the matter politely with the venue, but concerns were ignored. Requests of communication with the venue came to nothing. This experience makes it very clear to me that noise from this site is not being managed responsibly.

Another area of concern is the carpark of the venue which I can see from my kitchen window and my garden. I have tolerated for a long time my view being spoilt by litter, blue bins, a skip, and when they had a weekend event, portaloos and a huge marquee. One of my neighbours actually picked up a lot of the litter pictured – they were so tired of looking at it. I have attached photos of this at the bottom of the application form. Albion Farm/ The Turkey Shed are, quite rightly, very proud of the view from their venue and use it as a selling point. It is extremely disappointing that they have little consideration of how their carpark spoils the view for their neighbours. Should an outdoor licence be permitted, I can only envision this problem becoming worse as more people would be outside the venue which would increase the litter and the mess.

Protection of Children from Harm

The effect on young families in the area also troubles me; children need sleep and security, and loud music and late-night commotion undermine both. One of our neighbours at Thurston Clough farm has a young baby — outdoor music from the venue would most definitely affect both the baby and her already tired mother.

I understand the importance of supporting local business, but this proposal is too intrusive for our setting. It does not offer the protections that the Licensing Act requires, nor does it show respect for the residents who have made their lives here.

I therefore urge the licensing committee to refuse the outdoor activities element of their licence application – the permission to have live and recorded music outside, to show films outside, to have dance events outside and any other similar activities outside. I would also like the venue to plant some dense, fast growing trees along the perimeter at the top of their carpark (where you can see the blue bins in a line on the photo). This would block the view of their blue bins, the cars and the litter. The trees may also act as a bit of a barrier to the noise that carries across to us.

If these conditions were put in place, and the venue only had their activities such as music inside, the peaceful, rural character of our community, and the wellbeing of those of us who depend on its quiet and safety, can be preserved.

Licensing Objectives		
I am writing on behalf of myself, Nicola Brough and my husband Anthony Brough. The road we live on runs behind the Turkey Shed premises. I want to make it clear that I do not object to the Turkey Shed as it currently runs – it is a venue that I have used many times. However, I am writing to formally object to the new licence application for outdoor activities – films, live and recorded music, dance and other similar entertainment at The Turkey Shed. I respectfully ask the licencing committee to please consider the rural characteristics of the area and number of houses in close proximity to the venue when looking into the number of objections.		
The Prevention of Crime & Disorder We have already experienced disturbances from individuals congregating in The Turkey Shed car park, where noise regularly carries across to our homes. This is something we have been accepting of, as the noise from music inside the venue generally cannot not be heard. The proposed outdoor music aspect of the licence is likely to result in a substantial increase in visitor numbers – the Turkey Shed reported that their outdoor event on 20 th June 2025 saved their weekend takings. With an increase in numbers comes an increase in the noise and the risk of anti-social behaviour. The likelihood of late-night noise from patrons departing the premises, disturbance to nearby residents, and inappropriate activity within the vicinity is significant. This is especially the case for residents on Oldham Road who are regularly disturbed by people waiting for taxis in the lay by in front of their houses. The rural context of the site is not conducive to effective monitoring, enforcement, or mitigation of such impacts. The licensing objectives under the Licensing Act 2003 specifically require applicants to demonstrate how they will promote the prevention of crime and disorder and protect residents from public nuisance. In our view, this proposal fails to meet those requirements. Residents have chosen to live in this location for its quiet, rural character, and it is unreasonable to subject them to the disturbances associated with a venue which has the potential, under their licence application, to have large numbers of people visiting and music playing outside, up to 7 days a week.

The Prevention of Public Nuisance

Thurston Clough Road is a quiet rural area where residents value the peace and tranquillity of the surroundings. If the Turkey Shed were granted permission for outdoor activities, it would generate substantial noise that would carry across the fields and into nearby homes, particularly during evenings and weekends. With the geography of the area, and the surrounding hills, where we live on Thurston Clough Rd is badly affected by noise transmitted from the carpark. Outdoor amplified music is especially difficult to contain, and its impact would unreasonably undermine the amenity of local residents, many of whom have chosen to live here specifically for its quiet and peaceful character.

A recent example illustrates the issue. On Friday 20th June 2025, during hot weather, The Turkey Shed hosted a live singer performing outdoors on the roof of a shipping container. The noise level was wholly unacceptable: on our patio, we were unable to hear our own radio; inside our home, we could not hear our television unless doors and windows were closed. Even then, the noise of the performance remained audible indoors. We hold video evidence documenting the level of noise disturbance which is attached.

We attempted to address this politely and constructively by messaging the venue when the singer was on and asking that the speaker volume be reduced. My messages were read whilst the singer were performing and ignored (image 3 and 4). My husband's message was also ignored. The following day, he visited the venue in person and explained the issue to staff, leaving our contact details and requesting a call from the owners. They did not respond. He messaged again the next day and was ignored again (images 5 and 6). Our neighbours also sent a message on the evening of the outdoor singer, and this was also ignored.

Such experiences demonstrate that the noise impact from outdoor music at this venue is not being appropriately managed and that residents' concerns are certainly not being addressed. I do not have any faith that polite messages asking The Turkey Shed to please turn down the music (if an outdoor licence were to be granted) will be taken seriously and acted on. Comments on the Turkey Shed Facebook page (attached image 1) also demonstrate that the Turkey Shed think that it is acceptable that people should have to close their windows during a heat wave in order to be able to hear their TV in their own homes. The Turkey Shed are also contradictory about when their live music starts and finishes (attached image 1 and 2) which is extremely worrying given the outdoor elements of their licence application. This proposal therefore fails to satisfy the licensing objective of preventing public nuisance.

Protection of Children from Harm

Please state the reasons you believe granting the application will undermine this objective At least 2 of the residents of Thurston Clough Road have very young children. Regular exposure to loud music and late-night noise would negatively affect their ability to get to sleep and stay asleep. This is not good for a child's well-being, mental health or development. This was certainly the case with the event on 20th June 2025 when a neighbour informed me that her son had really struggled to get to sleep due to the level of noise he could hear in his house from the outdoor event at The Turkey Shed.

While I appreciate the desire to support local businesses; the outdoor music, films and dance element of the application is incompatible with this area and would have a disproportionate and detrimental effect on the majority of people who live in very close proximity to the Turkey Shed. If the Turkey Shed activities remain as they are, inside the venue, and we cannot hear them, I have no objections.

I therefore respectfully request that the outdoor permission for the activities B (exhibition of films outdoors), activities E(live music outdoors), activities F (recorded music outdoors), activities G (performance of dance outdoors) and activities H (entertainment of a similar description outdoors) be refused in order to safeguard the rural character of the area and to protect near by residents from ongoing noise nuisance and disruption.





We object to the proposed extension of hours and to the proposed variation to permit both internal and external areas to be used for live music etc. Our objections are based on experience of the noise levels emanating from the subject property as external areas have already been so used contrary to the conditions of the licence... The current licence limits entertainment to indoors. The premises are a converted agricultural building with poor acoustic attenuation. Music and amplified voices can be heard from outside our house and adjoining houses but are less audible internally. During June amplified music and singing was carried out outside the premises contrary to the current licence. The noise levels were such that they drowned the noise of cars and commercial traffic on Oldham Rd (A62) and conversation outside was difficult. The noise could easily be heard inside with doors and windows closed. We are not the closest house. The subject premises are situated off Oldham Rd with a narrow footpath adjoining (approx1m) and no safety barriers. People leaving use the lay-by adjacent to our house for taxi drop off/pick up with resultant noise into the


