1 Local By-Election Results

1.1 A local By-Election took place on 29th November 2018 and the following was elected to serve as Member of the Council as shown:

2 **Political Groups**

- 2.1 In addition to the result of the Local By-Election on 29th November 2018 the Leader of the Council has notified the Council that Councillor Rehman is no longer a Member of the Labour Group. Council is asked to note the composition of the political groups as notified under Regulation 8(1) of the Local Government (Committees and Political Groups) Regulations 1980.
 - i. The Labour Group 44 members
 - ii. The Liberal Democrat Group 8 members
 - iii. The Conservative Group 4 members
 - iv. Independent 4 Members

The Labour Group have lost a seat due to the changes in the composition of Political Groups from 59 seats to 58 seats, all other Political Group allocations remain the same as the political balance review agreed by Full Council on 12th September 2018.
