### Reason for Decision

The purpose of this report is to consider 1 letter of objection (see Appendix A) to the current proposal to introduce a Prohibition of Waiting Order on Otmoor Way, Royton, in the form of double yellow lines.

## Objection to the Proposed Prohibition of Waiting - Otmoor Way, Royton

# 1 Background

1.1 Complaints were received from residents of Otmoor Way via their Local Ward Member, requesting the introduction of waiting restrictions on Otmoor Way at is junction with Oldham Road, Royton to remove obstructive parking from within the junction.

### 2 Current Position

- 2.1 Observations revealed that a small number of residents do park in this location. In addition, the problem can be further exacerbated by parents/carers picking up and dropping of children not only at the start and finish of the school day from St Joseph's Primary but also Newbank Day Nursery located adjacent Otmoor Way on Oldham Road and whilst there are no specific start and finish times for the Nursery children, parents park for short periods of time throughout the day but the situation can continue over long periods of time.
- 2.2 When the proposal was advertised one objection was received (see Appendix B). The objection related to the proposed length of the double yellow lines, as they would cover the majority of the objector's driveway and they feel they will suffer if the restrictions are implemented at the proposed length.
- 2.3 The original proposal was considered to ensure the residents driveways would not be obstructed should motorist start to park directly at the end of the waiting restrictions. However, in light of the resident's objection, there is no reason why the proposed length of waiting restriction cannot be reduced outside their property. That said, should the residents find obstructive parking then occurs in front of their driveway their only option would be to apply for an Access Protection Marking which would need to be funded by themselves.
- 2.4 The objector also advised in his letter that the resident living opposite felt the same, however, to date no representation has been received from this resident. In light of the comments made, a letter was sent explaining the reason the 15 metres length of waiting restrictions was proposed and requesting they consider their options (see Appendix C). The objector has responded requesting the double yellow lines outside their property are reduced to 10 metres, however, no response again has been received from the other resident. In view of this it is recommended the Panel support the amendment to the proposal as shown in the schedule and plan at the end of this report.



# **Purpose of Report**

The purpose of this report is to consider the introduction of prohibitive waiting restrictions (double yellow lines) on Otmoor Way, Royton at its junction with Oldham Road to alleviate obstructive parking currently taking place.

### Recommendation

It is recommended that 'No waiting - at any time' restrictions to be introduced on Otmoor Way, Royton in accordance with the schedule at the end of this report.

# Proposed Prohibition of Waiting - Otmoor Way, Royton

# 1 Background

1.1 Complaints have been received from residents and Local Ward Members regarding obstructive parking on Otmoor Way within close proximity to its junction with Oldham Road. In light of the problematic parking taking place, it has been requested waiting restrictions in the form of double yellow lines be introduced on Otmoor Way.

### 2 Current Position

- 2.1 Observations have revealed a small number of residential vehicles do park on Otmoor Way within close proximity to its junction with Oldham Road, including a larger transit type van which can obstruct the free flow of traffic through the junction, when vehicles are waiting to exit and other vehicles are trying to enter Otmoor Way from Oldham Road.
- 2.2 In addition, to the above, parking does increase not only at the start and finish of the school day due to the close proximity of Saint Joseph's Primary School but also Newbank Day Nursery is located adjacent Otmoor Way on Oldham Road and whilst there are no specific start and finish times for the Nursery children, parents park for short periods of time throughout the day but the situation can continue over long periods of time.

## 3 Options/Alternatives

- 3.1 Option 1: To approve the recommendation to introduce waiting restrictions
- 3.2 Option 2: Not to approve the recommendation to introduce waiting restrictions.

## 4 Preferred Option

4.1 The preferred option is Option 1 to introduce waiting restrictions.

## 5 Justification

5.1 In view of the obstructive parking practices taking place it is felt that the introduction of waiting restrictions in the form of double yellow lines should be progressed.



Dear Sir/Madam.

I am writing to you regarding a Notice of a proposed parking restriction that is to be created at the junction of Otmoor Way with Oldham Road.

Our house and that of our neighbour, on the opposite corner, at number were the instigators of a request for the parking restrictions at this junction. On the other side of Oldham Road to us is a children's nursery. Unfortunately, parents dropping off or collecting children routinely park right on the junction often on both sides of the junction at the same time. We felt that this was potentially dangerous.

are grateful that the council have responded to this issue. However, our great concern is that the proposed markings are to run for 15 metres from the junction. This will run from Oldham Road virtually across both of our drives. Please note that we are the only two houses affected by this proposal. We will therefore suffer from bringing this safety issue to your attention.

Both ourselves and our neighbour would suggest that the line are run for 10 metres instead (a safety distance referred to in the Highway Code). This would take the lines just to the edge of our respective drives and indeed was what we discussed with the Councillor we asked to look into this issue.

Re: Proposed Prohibition of Waiting - Otmoor Way, Royton - TM3/993

I refer to the current proposal to introduce 15 metres of waiting restrictions (double yellow lines), on Otmoor Way at its junction with Oldham Road, Royton and your subsequent objection to the scheme.

I have noted your comments and I am happy to present your objection to the next Traffic Regulation Order (TRO) Panel with a view to reducing the restrictions by 5 metres so they are not in front of your driveway.

However, prior to submitting your objection, I would make you aware that in previous instances similar to this, where driveways have not been protected, motorists have been known to park at the end of the double yellow lines and obstruct driveway entrances.

Prior to a report being submitted to the TRO Panel, please could you consider the above as once the restrictions have been introduced and if obstructive parking results at your driveway the only alternative would be the introduction of Access Protection Marking, the current cost of which is £169.50 and this would need to be funded by yourself.

You have also explained your neighbour opposite is unhappy about the length of the restrictions, therefore, I would be obliged if you could make them aware of the situation.
