Reason for the decision: The purpose of this report is to seek approval to award grant funding to the voluntary, community and faith sector, during the financial year 1st April 2021 to 31st March 2022, as identified at Appendix 1.

Summary: The proposal seeks to approve funding to the voluntary, community and faith sector from the Council's Priority Programme and community cohesion funds.

In 2019/20, a 10% reduction was imposed upon the overall budget. Oldham CCG has since bridged the gap in funding by providing an allocation of £50k per annum and formalisation of the agreement to extend this to 2021/22 is currently underway.

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s): There are no alternative options to be considered at this stage.

Consultation has been undertaken with the Cabinet Member for Covid-19 recovery.

Separate consultation has taken place with the Chief Executive of Citizen's Advice Oldham (CAO) as a result of the proposal to extend CAO's funding for six months initially to allow time for the Place Based customer and financial support offer to be developed. A revised agreement will be developed with CAO once the review of the customer and financial support offer is completed.

Voluntary, community and faith groups listed at Appendix 1 will be provided with confirmation of their grant allocations following approval of the report.

Recommendation(s):

It is recommended that the proposed allocations are awarded in 2021/22 as outlined at Appendix 1.

Implications:

The cost of this proposal to award grants to the voluntary, community and faith sector in 2021/22 is £665,400.

The base revenue budget for 2021/22 is £646,940, this amount is to be augmented by a confirmed contribution from Oldham CCG of £50,000 (Mike Ward – Senior Accountant)



APPENDIX 2: BACKGROUND TO THE DECISION

1. Background:

- 1.1 The Council has provided core grant funding to voluntary, community and faith sector organisations through the Priority Programme Fund (PPF) for many years. The allocation of this budget has been reviewed at regular intervals and there are now only a small number of organisations who receive funding as a result of a reduction in the overall budget, changing Council priorities and the need to seek greater efficiencies and value for money.
- 1.2 Grant funding is also allocated as a contribution towards overheads and running costs to organisations which support the Council to deliver community cohesion (CC) related activity. The Stronger Communities Team manage a dedicated budget for community cohesion related activity and along with providing core grant funding, it is used to commission third party support to victims of hate crime, through Stop Hate UK.
- 1.3 The Council is currently leading the development of an approach to Place Based Working, which includes the customer and financial services offer. This new approach will incorporate the services delivered by Citizens Advice Oldham (CAO) and is likely to have implications for their funding agreement later in the year. It is proposed that £130,000 is initially awarded for a six-month period to allow time for the Placed Based Working model to be developed further. The remaining £130,000 will then be awarded to CAO once approval has been granted to implement the customer and financial services offer.
- 1.4 The Council has previously provided a small amount of grant funding as a contribution towards the delivery of annual community festivals, but due to Covid-19, there is no proposal at the current time to award funding for this purpose.
