Reason for the decision: The purpose of this report is to seek approval to

award grant funding from the Council's Priority Programme Fund to Citizens Advice Oldham (CAO) for the period 1st October 2021 to 31st March 2022 for the delivery of legal and advice

services.

Summary: Approval of funding to CAO for the period 1st April

to 30th September 2021 was incorporated within a separate delegated decision report titled 'Award

and allocation of Priority Programme and

Community Cohesion Funding to the voluntary, community and faith sector in 2021/22'. The funding award was requested for six months initially to allow time for the Place Based customer and financial support offer to be developed, which would incorporate the services provided by CAO. However, the implementation of this workstream has been delayed and as a result, a further

request is sought to extend the current arrangement with CAO until 31st March 2022.

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s):

If the Council chose not to enter into an agreement with Citizens Advice Oldham, residents would have no access to free legal and advice in the Borough, other than that provided by the Council's Welfare Rights service and lower level help provided by organisations (e.g. help with completing forms).

The Cabinet Member for Economic and Social Reform has previously been consulted on the proposal.

Recommendation(s):

It is recommended that £130,000 be awarded to Citizens Advice Oldham for the period 1st October 2021 to 31st March 2022 for the delivery of legal and advice services.

Implications:

What are the **financial** implications?

The preferred option is to award a further sixmonth funding to CAO at a cost of £130k.

The payment to CAO is fully budgeted in the Community Cohesion budget for 2021/22. Therefore, there are no adverse financial implications.

APPENDIX 1BACKGROUND TO THE DECISION

1. Background:

- 1.1 Priority Programme Funding (PPF) has been provided by the Council for many years as the main form of grant assistance to the voluntary, community and faith sector in the Borough and supports three strands of activity namely:
 - Third Sector Infrastructure
 - Legal and Advice Services
 - Community engagement and development
- 1.2 A grant allocation of £260,000 per annum is currently ringfenced to Citizens Advice Oldham (CAO) within the Council's Priority Programme Fund budget. Approval was previously granted to award £130,000 to CAO for the period 1st April to 30th September 2021. This report seeks approval to award a further £130,000 for the period 1st October 2021 to 31st March 2022 for the delivery of legal and advice services in relation to Level 1 and Level 2 general advice, Level 2 general help in the areas of debt, welfare benefits, housing, employment, immigration and asylum and Level 3 Specialist help in the area of housing to residents not eligible for Legal Aid.

2. Current Position:

- 2.1 The Council would usually seek approval at the start of the financial year to award the total grant allocation for legal and advice services to Citizens Advice Oldham. However, the Council has been working with internal service managers and partners to develop options for creating a Place Based customer and financial support offer, which would incorporate the services provided by CAO. As a result, approval was initially sought to award funding for the period 1st April 30th September 2021.
- 2.2 The expectation was that the new customer and financial support offer would be implemented by the end of September 2021. CAO's grant funding was therefore extended for a six-month period to allow sufficient time to explore a redesign of the service delivery model. However, the need for further negotiations with service managers and compliance with internal governance processes have resulted in the workstream being delayed.
- 2.3 In order to allow time for the workstream to develop further, there is a need to extend the existing grant arrangement with CAO until 31st March 2022 and award the remaining £130,000 allocated in 2021/22.
