1. AEI - Annual Engineers inspection of the Carriageway or Footway - this is carried out by Council Highway Engineers using their experience and knowledge to provide condition data of the asset that is used to identify types of treatments, lengths of defective asset. The survey also enables lifecycle analysis/planning of future maintenance needs and costs.

This survey is procured via mini competition via the Chest Northwest Procurement Portal.

2. Scrim – Sideway force Coefficient Routine Investigation Machine - this is a survey that measures the skidding resistance of the road when wet.

This survey is also feeds into the wider GM Combined Authority. The procurement route is via the GM Combined Authority framework set up specifically for Scrim surveys.

3. Scanner - Surface condition assessment for the National Network of Roads - this survey is carried out by state-of-the-art technology to provide compressive and completely objective surface and structural condition.

Procurement route is via the GM Combined Authority framework set up specifically for Scanner surveys.
