Subject: Proposed Traffic Calming and Extension of 20mph Zone – Partington Street, Failsworth (M1038)

Ward (s): Failsworth East

Reason for the decision:

The redevelopment of the former Lower Failsworth School site at Partington Street, Failsworth, has resulted in an increase in housing density in the area. The new properties are in close proximity to schools in the area - St Johns Primary School and Failsworth Academy, and it is considered that the provision of traffic calming measures (pairs of speed cushions) and the introduction of a 20 mph zone along Partington Street will enhance road safety for schoolchildren and parents walking and / or cycling to both educational facilities.

This report seeks permission to formally advertise the 20 mph speed limit and speed cushion locations

The proposals are detailed on drawing number 2384 / A4 / 135 / 1 and in the schedules at the end of this report.

Officers have previously consulted on a traffic calming scheme along Partington Street which met with objections from residents; this has been revised and a pre-consultation has been well received.

Summary:

The purpose of this report is to seek approval to the advertise the legal Humps Notice as set out in The Highways (Road Humps) Regulations

1999 and the Road Traffic Regulation Act 1984, and the introduction of a 20mph zone along Partington Street

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s):

Option 1 – Introduce the scheme as proposed which will greatly enhance road safety for vulnerable users and regulate the speed of vehicles along this route.

Option 2 - The alternative option is not to progress with the road safety measures and continue with the traffic conditions as they are at present.

Justification:

If approved, the proposal will:

- Supplement existing traffic calming measures in the vicinity and help reduce vehicle speeds and improve road safety in the vicinity of nearby schools
- Encourage walking/cycling/scooting to school

The Ward Members have been consulted and no comments have been received.

Recommendation(s):

It is recommended the traffic the traffic calming measures and 20mph speed limit be introduced along Partington Street in accordance with the schedules at the end of this report

The cost for the advertising and delivery of the traffic calming scheme at Partington Street, Failsworth is as follows:

The cost of advertising the notice will be £1.4k and will be funded from within the Highways revenue budget.

The capital cost of £12k for the delivery of this scheme will be funded from the 'Partington Street, Failsworth – Traffic Calming' scheme within the 2023/24 Transport Capital Programme, which is financed by LTP Highway Maintenance Grant. (John Edisbury)

*What are the **legal** implications?*

In relation to the proposed speed cushions, the Council should satisfy itself that the proposals will be effective in reducing or preventing road accidents and will justify the expenditure incurred. It will be necessary to publish details of the proposals in one or more local newspapers and consider any objections received before deciding whether to proceed with the proposals.

In relation to the proposed 20 mph speed limit proposals, the speed limit regime enables traffic authorities to set 'local speed limits' in situations where local needs and considerations deem it desirable for drivers to adopt a speed which is different from the respective national speed limit. Before changing a local speed limit the Council should satisfy itself that the benefits exceed the disbenefits. The Council should assess a number of factors including accident and casualty savings and conditions and facilities for vulnerable road users. The estimated collision and injury savings should be an important factor when considering changes to a local speed limit.

In addition to the above, under section 122 of the Road Traffic Regulation Act 1984, it shall be the duty of the Council so to exercise the functions conferred on them by the Act as to secure the

expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. Regard must also be had to the desirability of securing and maintaining reasonable access to premises, the effect on the amenities of any locality affected and the importance of regulating and restricting the use of roads by heavy commercial vehicles so as to preserve or improve the amenities of the areas through which the roads run, the strategy produced under section 80 Environmental Protection Act 1990 (the national air quality strategy), the importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles and any other matters appearing to the Council to be relevant. 


