## Trent Road and Cheviots Road, Shaw – Proposed Prohibition of Waiting

# Decision (s) <sup>2</sup>

To seek approval for the introduction of prohibitive waiting (double yellow lines) along part of Trent Road, Shaw.

#### Reasons for the decision(s)<sup>3</sup>

Transport for Greater Manchester have asked that improvements be made to an existing bus stop arrangement at Trent Road, Shaw to enable bus passengers to board and alight the bus from a full height kerb. To achieve this, it will be necessary to move the bus stop area further into the carriageway and introduce a footway build out area for the bus to pull up to. The bus stop is also a timing point which means buses can be stationary at the stop for periods of up to 5 minutes.

On the opposite side of the carriageway vehicles are regularly parked on the street which makes access difficult for moving traffic along Trent Road, when there is a stationary bus stopped for a longer period of time. It is therefore felt that the ability to park on the opposite side of the road to the bus stop should be removed by the introduction of double yellow lines.
