Programme for non-domestic childcare providers

Reason for the decision:

Permission is being sought to utilise the 1 year extension available under the Council's contract with Early Years Alliance for the provision of the Quality Improvement Programme for nondomestic childcare providers (nurseries & preschools) with a funding envelope of £30k.

The contract with Early Years Alliance for the delivery of the Quality Improvement Programme for non-domestic childcare providers locally commenced on 10 October 2022 for 1 year with the option to extend the for a further 1 year.

The programme will continue to offer value for money as a saving of £10,000.00 will be achieved in the extension period from the original contract.

The programme will respond to the local authority statutory duties of responding to providers deemed to be less than 'good', including those who have received concern and compliance visits from Ofsted. The programme

will help to ensure that Oldham's non-domestic childcare providers continue to deliver high quality Early Years education.

Local authorities are required by legislation to secure training for:

- those registered on the Ofsted Early
 Years Register who are judged less than 'good'
 by Ofsted in their most recent inspection report;
- newly registered providers on the Ofsted Early Years Register who have not yet had an inspection report published;

An Invitation to provide Quotes (ITQ) was issued on the Due North Portal "The Chest" with a return date of the 3 August 2022. ITQ submissions were received from 2 organisations:

- Early Education
- Early Years Alliance

A comprehensive selection process was undertaken by an evaluation panel and a scoring moderation meeting was held on the 24 August 2022. The outcome of this process was that Early Years Alliance was identified as having submitted the most commercially advantageous quote.

A contract was entered into with Early Years Alliance for 1 year with the option to extend for 1 year with effect from 10 October 2022.

Summary:

This report seeks approval to utilise the 1 year extension period under the contract with Early Years Alliance to enable the continued delivery of a Quality Improvement Programme for non-domestic childcare providers locally.

What are the alternative option(s) to be considered? Please give the reason(s) for recommendation(s):

Option 1: Approval for the for the 1 year extension of the contract with Early Years Alliance.

A formal ITQ process has been undertaken which made provision for the extension.

Emerging risks will be managed through formal contract monitoring processes.

Option 2: Not approve the extension of the Early Education contract to extend the term by 1 year

This could pose a risk to the sufficiency for

childcare in Oldham, as not awarding the contract would lead to poor quality provision for Early Years and resulting in large numbers of Ofsted judgements becoming less than good.

What are the **Human Resources** implications?

This report seeks a one-year extension of a contract with a provider to deliver a Quality Improvement Programme to non-domestic Childcare Settings. Whilst not included in the body of this report, the specifications of the tender include 90 visits across 30 settings as well as termly training delivering at Network events. The cost provides value for money and can be funded through the General Training Budget (GTB).

However, as this is an ongoing need for the service, it is worth considering whether an internal job position could be created to cover this work. At the current cost, it may not be feasible, as on-costs may result in this being a more expensive option. But in future if there is potential to alleviate the cost from the GTB and reinvest this back into workforce training, then it's something that should at least be explored.
