Holcroft Moss Planning Obligations Supplementary Planning Document SEA Screening Determination Statement

September 2024

1. Strategic Environmental Assessment Introduction

- 1.1. The nine Places for Everyone (PfE) Plan local authorities (Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, Trafford and Wigan) are jointly preparing a Holcroft Moss Planning Obligations Joint Supplementary Planning Document (SPD). The nine PfE Plan authorities are the "responsible body" for the purposes of this SEA screening determination statement.
- 1.2. This statement sets out the determination of the need for a Strategic Environmental Assessment (SEA) in accordance with Regulation 9 (3) of the Environmental Assessment of Plans and Programmes Regulations 2004 and European Directive 2001/42/EC for the Draft Holcroft Moss Planning Obligations Joint Supplementary Planning Document (SPD).

2. Strategic Environmental Assessment Context

- 2.1. The requirement for a SEA is set out in the Environmental Assessment of Plans and Programmes Regulations 2004 (the Regulations), which implements the requirements of the European Directive 2001/42/EC.
- 2.2. The SEA Directive (2001/42/EC) identifies the purpose of SEA is "to provide for a high level of protection of the environment and to contribute to the integration of environmental considerations into the preparation and adoption of plans and programmes with a view to promoting sustainable development". It requires the determination as to whether the plan or programme under assessment is likely to have significant environmental effects, taking account of the criteria set out in Schedule 1 of the Regulations. The Regulations require that the results of this process are set out in a Screening Determination Statement (this document), which must be publicly available.
- 2.3. Before making a formal determination in relation to SEA, there is a requirement to consult the three statutory consultation bodies designated in the Regulations (the Environment Agency, Historic England, and Natural

- England) on whether environmental assessment is required. This was undertaken and their responses to the consultation are at Appendix 2 of this statement.
- 2.4. The Planning Practice Guidance (Paragraph: 008 Reference ID: 11-008-20140306) states that: "Supplementary Planning Documents do not require a Sustainability Appraisal but may in exceptional circumstances require a Strategic Environmental Assessment if they are likely to have significant environmental effects that have not already been assessed during the preparation of the relevant strategic policies".

3. Draft Holcroft Moss Planning Obligations Supplementary Planning Document (SPD)

- 3.1. Annex 2 of the National Planning Policy Framework (NPPF) defines SPDs as documents which add further detail to the policies in the Development Plan. As SPDs do not have the same status as policies contained within the Development Plan, they are not subject to independent examination.
- 3.2. The Places for Everyone (PfE) Plan was adopted by, Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, Trafford and Wigan (the nine PfE Plan authorities) and took effect on 21 March 2024. The SPD sets out how the nine PfE Plan authorities will seek to secure contributions from developers to mitigate the impacts of development proposals on Holcroft Moss, which emerged through the PfE Plan making process (and also Warrington's Local Plan) and through detailed discussions with Natural England.
- 3.3. The aims of the Holcroft Moss Planning Obligations SPD are to:
 - Ensure that advice is consistent with the latest Government regulations and associated Planning Practice Guidance;
 - Ensure that new development is consistent with the provisions of the recently adopted PfE Plan;

- Provide a robust basis upon which the nine PfE Plan authorities can secure contributions from developers to ensure that the impacts of schemes on Holcroft Moss are appropriately mitigated; and
- Provide clear advice to developers as to what is expected in applications to ensure an efficient process for consultation and determination.
- 3.4. The PfE Plan is the "parent DPD", which has already been subject to Sustainability Appraisal incorporating Strategic Environmental Assessment, prior to being adopted and coming into effect on 21 March 2024.
- 3.5. The Draft Holcroft Moss Planning Obligations SPD will supplement PfE Plan Policy: Policy JP-C8: Transport Requirements of New Development.
- 3.6. The SPD will provide guidance on the application of S106 agreements that form the basis of developer contributions in respect of matters relating to the mitigation of impact from development on Holcroft Moss. It will be a material consideration in the determination of planning applications for the whole of the PfE Plan area upon adoption.
- 3.7. The information and guidance in the SPD will be of particular use to those looking to submit planning applications to one or more of the PfE Plan authorities. It will provide practical advice to help applicants comply with PfE Plan policy requirements. It also sets out the procedure for determining planning applications, what information will be required and when it will be required.

4. Screening Determination

4.1. The Draft Holcroft Moss Planning Obligations SPD is not setting new policy; it will supplement an existing policy (JP-C8) in the PfE Plan (which came into effect on 21 March 2024). JP-C8 has already been subject to SA/SEA and HRA, through the PfE Plan making process. The screening of the Draft Holcroft Moss Planning Obligations SPD is set out in Appendix 1 of this document.

- 4.2. The PfE Plan authorities consider that after having regard to the Environmental Assessment of Plans and Programmes Regulations 2004 the Holcroft Moss SPD does not require a Strategic Environmental Assessment (SEA).
- 4.3. They have come to this view as:
 - The SPD sits beneath the PfE Plan, which provides a policy framework for the location, nature and scale of growth and link to retained EU law. As with the Warrington Local Plan, the PfE Plan has been through the SEA process and any required mitigation is already identified:
 - The SPD's purpose is to ensure new development mitigates adverse impacts on the protected habitats and species at Holcroft Moss.
 - The SPD provides guidance on PfE Plan Policy JP-C8 Transport
 Requirements of New Development, which has been informed by the
 outcome and recommendations of the associated Habitats
 Regulations Assessment.

5. Consultation with the statutory bodies

- 5.1. Having prepared an initial screening determination statement, the competent authorities consulted the Environment Agency, Historic England and Natural England, in accordance with the Environmental Assessment of Plans and Programmes Regulations 2004. On behalf of the nine PfE authorities, the documents were, at the same time, also made available on the GMCA's website. The purpose of this consultation was to establish whether organisations/interested parties agreed with the outcome of the initial screening.
- 5.2. Each of the statutory bodies have confirmed that they agree with the competent authorities' conclusion that the proposed Holcroft Moss Planning Obligations SPD would not require a full Strategic Environmental Assessment or a Habitats Regulations Assessment.

5.3. The relevant correspondence is attached at Appendix 2.

6. Conclusion

6.1. Given the outcome of this assessment and the response of the statutory consultees, provided at Appendix 2, the competent authorities have concluded that a full Habitats Regulations Assessment is not required for the Holcroft Moss Planning Obligations SPD.
