## Reason for decision

The purpose of this report is to seek approval to award grant funding to the voluntary, community and faith sector, namely Oldham Interfaith Forum and Stop Hate UK, during the financial year 1<sup>st</sup> April 2026 to 31<sup>st</sup> March 2027

## Recommendation(s)

The recommendation is to award funding at the same level in 2026/27 (i.e., £36,000 to Oldham Interfaith Forum and £4,400 to Stop Hate UK).

## Background

Funding has been allocated for several years as a contribution towards overheads and running costs to organisations which support the Council to deliver community cohesion related activity namely Oldham Interfaith Forum and Stop Hate UK.

### Oldham Interfaith Forum

Oldham Council awards £36,000 per annum to Oldham Interfaith Forum (OIFF). OIFF supports the Council in building good relations in Oldham with a particular focus on improving understanding between people from different faith backgrounds (particularly young people through work in schools) and supporting dialogue within and between faith communities about issues of concern.

OIFF employs two members of staff who assist the Council in managing community tensions and preventing conflict and providing mechanisms to work constructively with faith leaders through the OIFF and Oldham Mosques Council. They offer support to the Council in engaging with faith communities and ensuring that Council services are sensitive to the needs of faith communities.

### Stop Hate UK Helpline

Oldham Council awards £4,400 per annum to Stop Hate UK to provide a third-party helpline for victims/ witnesses to report hate crimes and incidents.

The 24 hour 'Stop Hate Line' provides an additional means for reporting incidents of hate crime and takes forward Recommendation 16 of The Stephen Lawrence Inquiry Report: 'That all possible steps be taken by police services at local level, in consultation with local government and other agencies and local communities, to encourage the reporting of racist incidents and crimes. This should include:

- The ability to report at locations other than police stations.
- The ability to report 24 hours a day.'

The Stop Hate Line covers the five monitored strands of hate crime which are:

- Race
- Faith
- Disability
- Sexual orientation
- Gender identity

There are no alternative options to be considered at this stage.

### **Risks**

The report provides details of the opportunities provided by the funding to OIFF and Stop Hate UK who support the Council to deliver community cohesion and an alternative reporting mechanism for Hate Crime victims. The Stronger Communities Service will continue to monitor activity to ensure the most appropriate use of resources from the organisations.
