### **Public Protection Service Scheme of Delegation for licences, permits and registrations**

#### **Reason for Decision**

The purpose of this report is to update the scheme of delegation for licensing matters and other permissions within the Public Protection Service of the Economy, Skills and Neighbourhoods Directorate which was last reviewed in June 2015.

#### **Recommendations**

The Executive Director is recommended to:

- a) Note the report;
- b) Delete the powers under the Licensing Functions listed in the current scheme approved on the 5<sup>th</sup> June 2015; and
- c) Delegate powers under the Licensing Functions listed in Columns A and B of Schedule A to this report to the officers listed in Column C to the extent permitted by law and to the extent established in Column D of the same schedule.

## **1      Background**

1.1 The power to delegate Licensing functions is contained within the Council's Constitution. For matters under the remit of the Licensing Committee these can be further delegated by the Executive Director (Economy, Skills and Neighbourhoods). For matters that are an Executive Function and are not reserved to Cabinet the Executive Director has delegations which, again, can be further delegated to Officers.

## **2      Current Position**

2.1 The current scheme of delegation was approved on the 5<sup>th</sup> June 2015. A periodic review takes place of such delegations and at the latest review a number of changes have been proposed. These are:

- Including Highways Officers in permission to grant permits;
- Powers to revoke licences where Immigration status changes;
- Making it clear that no new taxi licences will be granted by Officers where allegations/convictions relating to sexual offences are listed;
- That no taxi licence shall be granted or renewed unless a valid DBS certificate is in force;
- A taxi driver licence may be suspended where he/she has failed to attend the driver awareness training;
- Allowing the delegation for the revocation of vehicle licences where it is necessary to do so without the need for a hearing.

## **3      Consultation**

3.1 All teams affected by the proposed changes have been consulted on the implications of this scheme of delegation. The Chair of the Licensing Committee has also noted the report.

## **4      Recommendation**

4.1 The Executive Director is recommended to:

- (i) Note the report;
- (ii) Delete the powers under the Licensing Functions listed in the current scheme approved on the 5<sup>th</sup> June 2015
- (iii) Delegate powers under the Licensing Functions listed in Columns A and B of Schedule A to this report to the officers listed in Column C to the extent permitted by law and to the extent established in Column D of the same schedule.

## **5 Financial Implications**

- 5.1 The report sets out details of the scheme of delegation for licensing functions from the Executive Director to the Licensing team. There are no financial implications as a result of this proposal.

## **6 Legal Services Comments**

- 6.1 Under Oldham Council's Scheme of Delegation contained in the Constitution, the Executive Director, Neighbourhoods is authorised to discharge any functions of the council relating to Trading Standards, Licensing and Highways, with the exception of those matters reserved to the Executive or any Regulatory Committee. Under Part 3 of the Council Constitution, the Licensing Committee (being a Regulatory Committee) has delegated powers to consider and determine all applications for licences and permissions issued by or on behalf of the Council, including attaching conditions thereto, to consider and determine all applications for review, continuation, transfer, variation, renewal, suspension, closure orders, forfeiture or revocation of all licences and permissions issued by or on behalf of the Council, including attaching conditions thereto. In November 2013, the Committee delegated the following functions surrounding licences, registrations and permissions to the Executive Director (Neighbourhoods):- grants, renewals, refusals, variations, suspensions, cancellations and revocations.
- 6.2 The Scheme of Delegation also provides for officers to delegate further any function which has been delegated to them under the Scheme to another officer or officers of suitable experience and seniority. Each Executive Director is required to prepare a Departmental Scheme of Delegations which sets out how decisions will be made in his/her department. This report deals with the Departmental Scheme of Delegations in relation to licensing functions. (A Evans)

# **Scheme of Delegation**

## **Public Protection Service**

## **Background**

Section 101 of the Local Government Act 1972 sets out the framework of delegation. That section provides that a Council can arrange for the discharge of its functions through a committee, subcommittee or officer of the authority, or any other local authority. Committees can delegate to subcommittees or to officers, and subcommittees can delegate to officers, unless expressly prohibited.

It is the Council which is entrusted with the power, and it is the Council which must exercise it. Therefore, the appearance of acting under the direction of another body will render the exercise of power unlawful.

Subject only to the very limited exceptions in s101, (for example, setting the council tax, and considering certain reports from designated officers), there are few limits on the extent of the delegation to officers which local authorities are permitted to make.

Within Oldham, Part 3 of the Council's Constitution - 'Responsibility for Functions', sets the Scheme of Delegation to Executive Directors; however, footnotes to the Scheme make it clear, that the Director may arrange for such delegation to be exercised by an officer of suitable experience and seniority, but the Director remains responsible for any decision taken pursuant to the delegation arrangements.

Part 3 of the Council's Constitution also sets out that each Executive Director will prepare a Departmental Scheme of Delegations which sets out how decisions will be made in his/her department. This should establish which officers will be given authority to make decisions under the Executive Director's delegated powers, and subject to which terms and conditions. Departmental Schemes of Delegations will be lodged with the Chief Executive and made available to the public on request. It is under this framework tha this Scheme of Delegation is prepared.
